# General Information

## **Written Reciprocity Agreement**

The Office of Attorney General may negotiate written “reciprocity agreements” with other states to allow residents of each state to carry a concealed firearm in the other state. The Pennsylvania Uniform Firearms Act of 1995 grants the Attorney General the “the power and duty to enter into reciprocity agreements with other states providing for the mutual recognition of a license to carry a firearm issued by the Commonwealth and a license to carry a firearm issued by the other state.” 18 Pa.C.S. § 6109(k). The Attorney General is “authorized to negotiate reciprocity agreements and grant recognition of a license to carry a firearm issued by another state.” *Id.*

## **Mutual Statutory Reciprocity**

In some circumstances, the Attorney General may grant mutual reciprocity without a written agreement. Under 18 Pa.C.S. § 6106(b)(15), the Attorney General may grant statutory reciprocity where: (1) the other state grants recognition to Pennsylvania concealed carry licenses through its laws and (2) that state’s laws governing firearms are sufficiently similar to the firearms laws of Pennsylvania.

## **Unilateral Recognition by Another State**

Unilateral recognition occurs when another state recognizes the validity of Pennsylvania concealed carry licenses regardless of whether Pennsylvania is able to recognize concealed carry licenses issued by that state or that state does not require a license to carry a concealed firearm.

## **Review of Reciprocity**

Under 18 Pa.C.S. § 6109(m), the Attorney General must annually contact each state with which Pennsylvania does not have a written reciprocity agreement to determine whether (1) it is willing to negotiate a reciprocity agreement with Pennsylvania, (2) a Pennsylvania concealed carry licensee may carry a concealed firearm in that state, and (3) a Pennsylvania concealed carry licensee may apply for a separate concealed carry license from that state. In addition, the Office of Attorney General contacts each state on an annual basis to review their firearms laws and reciprocity status.

The Office of Attorney General also conducts a targeted review whenever it becomes aware that another state's laws have changed. You may help the Office of Attorney General by reporting a change in another state's laws [HERE](#)<sup>2</sup>.

## **Terminology**

*Pennsylvania Concealed Carry License* – Throughout this document, the term “Pennsylvania concealed carry license” means a license to carry a concealed firearm issued by the Commonwealth of Pennsylvania under 18 Pa.C.S. § 6109 of the Pennsylvania Uniform Firearms Act.

*Concealed Carry License* – Throughout this document, the term “concealed carry license” means a license to carry a concealed firearm issued under the laws of any state other than the Commonwealth of Pennsylvania.

## Carrying a Concealed Firearm in Pennsylvania

Pennsylvania residents who wish to carry a concealed firearm in Pennsylvania must have a valid Pennsylvania concealed carry license to do so legally. 18 Pa.C.S. § 6109(b) states that “an individual who is 21 years of age or older may apply to a sheriff for a license to carry a firearm concealed on or about his person or in a vehicle within [Pennsylvania].” Pennsylvania residents generally must file their application for a concealed carry license with their county sheriff; however, residents of Philadelphia must apply with the chief of police. **A concealed carry license issued by another state does not allow a Pennsylvania resident to legally carry a concealed firearm in the Commonwealth of Pennsylvania.**

## States Whose Residents, 21 and Older, Can Carry a Concealed Firearm in Pennsylvania with Only a License from That State

Pennsylvania recognizes concealed carry licenses issued by states without applying for a separate Pennsylvania concealed carry license – if the concealed carry license holder is (1) a *resident* of that state and (2) *21 years of age or older*. Pennsylvania specifically recognizes concealed carry licenses from the following states regardless of reciprocity type:

This Reciprocity Agreement is between the Commonwealth of Pennsylvania, by and through its Office of Attorney General, and the State of Alaska, by and through its Department of Public Safety (together, the "Parties").

**WHEREAS**, the purpose of this Reciprocity Agreement is to mutually extend reciprocal concealed firearm carry license privileges to the residents of the Commonwealth of Pennsylvania and the State of Alaska;

**WHEREAS**, the Commonwealth of Pennsylvania authorizes individuals, with a license issued under 18 Pa.C.S. § 6109 (the "PA License"), to carry a concealed firearm;

**WHEREAS**, the State of Alaska authorizes individuals, with a license issued under AS § 18.65.700 (the "AK License"), to carry a concealed firearm;

**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania is authorized by 18 Pa.C.S. § 6109(k) to enter into a reciprocity agreement with the State of Alaska providing for the recognition of AK Licenses;

**WHEREAS**, the Alaska Department of Public Safety is authorized by AS § 18.65.775(b) to enter into a reciprocity agreement with the Commonwealth of Pennsylvania providing for the recognition of PA Licenses;


**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania has determined that the AK License meets the requirements for reciprocity in the Commonwealth of Pennsylvania;


**WHEREAS**, the Department of Public Safety of the State of Alaska has determined that the PA License meets the requirements for reciprocity in the State of Alaska; and

**NOW, THEREFORE**, in consideration of the mutual benefits and obligations set forth in this Reciprocity Agreement, the Parties hereby agree and covenant as follows:

1. The recitals above are reaffirmed and incorporated herein as material provisions of this Reciprocity Agreement.
2. The Commonwealth of Pennsylvania shall recognize all valid AK Licenses issued to legal residents of the State of Alaska who are 21 years of age or older; the rights and privileges of AK License holders recognized under this Reciprocity Agreement shall be the same as, and not greater than, those rights and privileges granted to PA License holders under Pennsylvania law.

3. The State of Alaska shall recognize all valid PA Licenses; the rights and privileges of PA License holders recognized under this Reciprocity Agreement shall be the same as, and not greater than, those rights and privileges granted to AK License holders under Alaska law.
4. This Reciprocity Agreement applies only to the carrying of concealed firearms and not to any other types of weapons.
5. The Commonwealth of Pennsylvania and the State of Alaska will promptly inform each other of any changes in their respective concealed carry firearm license statutes and provide a copy of the revised statutes, as any changes may impact the validity of this Reciprocity Agreement.
6. This Reciprocity Agreement is contingent upon and shall remain effective only as long as the respective statutory authority set forth above continues to authorize the Parties to grant reciprocal privileges.
7. This Reciprocity Agreement shall become immediately effective, and rescind and replace any prior agreement, upon its execution by the Parties and shall continue in effect unless modified or terminated by the Parties in writing.
8. This Reciprocity Agreement may be terminated by either Party upon thirty (30) calendar days' written notice.
9. AK License holders carrying a concealed firearm in the Commonwealth of Pennsylvania under this Reciprocity Agreement shall comply with all applicable laws, rules, and regulations of the Commonwealth of Pennsylvania.
10. PA License holders carrying a concealed firearm in the State of Alaska under this Reciprocity Agreement shall comply with all applicable laws, rules, and regulations of the State of Alaska.
11. This document is not intended to and shall not limit or restrict the statutory authority or jurisdiction of the Parties.

**WHEREAS**, the Commonwealth of Pennsylvania authorizes individuals, with a license issued under 18 Pa.C.S. § 6109 (the "PA License"), to carry a concealed firearm;

**WHEREAS**, the State of Arizona authorizes individuals, with a license issued under ARS § 13-3112 (the "AZ License"), to carry a concealed firearm;

**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania is authorized by 18 Pa.C.S. § 6109(k) to enter into a reciprocity agreement with the State of Arizona providing for the recognition of AZ Licenses;

**WHEREAS**, the Arizona Department of Public Safety is authorized by ARS § 13-3112(R) to enter into a reciprocity agreement with the Commonwealth of Pennsylvania providing for the recognition of PA Licenses;

**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania has determined that the AZ License meets the requirements for reciprocity in the Commonwealth of Pennsylvania;


**WHEREAS**, the Department of Public Safety of the State of Arizona has determined that the PA License meets the requirements for reciprocity in the State of Arizona; and

6. This Reciprocity Agreement is contingent upon and shall remain effective only as long as the respective statutory authority set forth above continues to authorize the Parties to grant reciprocal privileges.
7. This Reciprocity Agreement shall become immediately effective, and rescind and replace any prior agreement, upon its execution by the Parties and shall continue in effect unless modified or terminated by the Parties in writing.

**WHEREAS**, the purpose of this Reciprocity Agreement is to mutually extend reciprocal concealed firearm carry license privileges to the residents of the Commonwealth of Pennsylvania and the State of Florida;

**WHEREAS**, the Commonwealth of Pennsylvania authorizes individuals, with a license issued under 18 Pa.C.S. § 6109 (the “PA License”), to carry a concealed firearm;

**WHEREAS**, the State of Florida authorizes individuals, with a license issued under F.S. § 790.06 (the “FL License”), to carry a concealed firearm;

**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania is authorized by 18 Pa.C.S. § 6109(k) to enter into a reciprocity agreement with the State of Florida providing for the recognition of FL Licenses;

**WHEREAS**, the Florida Department of Agriculture and Consumer Services is authorized by F.S. § 790.015 to enter into a reciprocity agreement with the Commonwealth of Pennsylvania providing for the recognition of PA Licenses;

**WHEREAS**, the Office of Attorney General of the Commonwealth of Pennsylvania has determined that the FL License meets the requirements for reciprocity in the Commonwealth of Pennsylvania;

4. This Reciprocity Agreement applies only to the carrying of concealed firearms and not to any other types of weapons.
5. The Commonwealth of Pennsylvania and the State of Florida will promptly inform each other of any changes in their respective concealed carry firearm license statutes and provide a copy of the revised statutes, as any changes may impact the validity of this Reciprocity Agreement.
6. This Reciprocity Agreement is contingent upon and shall remain effective only as long as the respective statutory authority set forth above continues to authorize the Parties to grant reciprocal privileges.
7. This Reciprocity Agreement shall become immediately effective, and rescind and replace any prior agreement, upon its execution by the Parties and shall continue in effect unless modified or terminated by the Parties in writing.
8. This Reciprocity Agreement may be terminated by either Party upon thirty (30) calendar days' written notice.
9. FL License holders carrying a concealed firearm in the Commonwealth of Pennsylvania under this Reciprocity Agreement shall comply with all applicable laws, rules, and regulations of the Commonwealth of Pennsylvania.
10. PA License holders carrying a concealed firearm in the State of Florida under this Reciprocity Agreement shall comply with all applicable laws, rules, and regulations of the State of Florida.
11. This document is not intended to and shall not limit or restrict the statutory authority or jurisdiction of the Parties.






**WHEREAS**, Handgun License reciprocity between Mississippi and Pennsylvania is thus supported by the laws of both states;
