 - Other workgroups as needed




Goal: Reduce Recidivism

Jail Collaborative Reentry Program

- Re-Entry staff includes Jail Service Coordinators,
 Community Support Coordinators, Family Support
 Specialists, Reentry Probation Officers, and contracted service providers
- The Re-Entry staff provide wrap around services including family support to facilitate family reunification. Probation officers promote a balance between the court conditions and rehabilitative aspects of community supervision.

Jail Collaborative Reentry Program

Target Population

- Inmates serving an Allegheny County Court Sentence or detained in the Jail with no open charges
- Medium or high risk to recidivate
- Have an Allegheny County term of parole or probation following their sentence

Jail Collaborative Reentry Program Phase 1

- Phase 1 includes an assessment, the development of a service plan and referral into Re-Entry services.
- Eligible participants will participate in services offered by a variety of providers.
 - Education
 - Adult Basic Education/Literacy to GED
 - Computer literacy
 - Pre-apprenticeship
 - Creative writing
 - Family relations, parenting, and family reunification
 - Cognitive Behavioral Therapy (Thinking for a Change)
 - Drug and Alcohol
 - Batterers' Intervention (BIP)
 - Employment Training

Focus on Employment and Training

Training Opportunities

- New Century Careers (Machining Program): Inmates are able to access this training in our newly built Machine Shop inside of the jail. Upon release they complete their certification requirements at the NCC training facility.
- □ **Pittsburgh Community Kitchens:** a Culinary Arts training program available only in the community.
- □ **Pittsburgh Trade Institute:** a Masonry training program available only in the community.
- □ **A. Phillip Randolph Institute:** a program offering life skills and technical training for the trades

Jail Collaborative Reentry Program Phase 2

In Phase 2, wraparound services are provided by Community Support Specialists and Re-entry Probation Officers for up to 6 months after release. These services include:

- Housing location assistance
- Rent, food and clothing assistance
- Probation Incentives
- Photo ID
- Linkage to Medical and Public Assistance
- Transportation
- Referral to community services including aftercare,
 job training, and job placement services
