AFFIDAVIT of PROBABLE CAUSE CONTINUATION

Your Affiant is a Special Agent with the Pennsylvania Office of Attorney General. Your Affiant has been a law enforcement officer for over 12 years. Your Affiant has been employed as a Special Agent with the Pennsylvania Office of Attorney General since 2017. Prior to the current position of Special Agent, your Affiant was employed with the Pennsylvania State Police Bureau of Liquor Control Enforcement for 8 years, employed as an Investigator for the First Judicial District of PA for 3 years and was also employed as a Municipal Police Officer in North Wildwood, NJ in 2005. Your Affiant has a background in criminal and felony investigations. Your Affiant is currently an affiliate member of the Pennsylvania Internet Crimes Against Children Task Force (hereinafter referred to as PA ICAC). PA ICAC specially trains on and investigates crimes against children. Specifically, your Affiant is assigned to investigate crimes involving the online sexual exploitation of children. Your Affiant has been investigating internet crimes against children since July of 2017. Your Affiant has been trained in peer to peer file sharing through ICAC and completed the BitTorrent training program in 2017.

Additionally, as previously noted, your Affiant is a PA ICAC affiliate member. This PA ICAC Task Force is a statewide task force responsible for investigating cases involving the sexual exploitation of children via the internet. Your Affiant's duties include, but are not limited to, investigating violations of state law, such as the online exploitation of children. Your Affiant investigates violations of Title 18, Section 6312, which criminalizes the possession, receipt, and transmission of child pornography.

On Tuesday, 07/25/18, Your Affiant along with other agents from the Office of the Attorney General's Child Predator Section executed a search warrant at 7201 Bradford Road Apartment D207, in Upper Darby, Delaware County, for evidence related to an investigation into the possession, receipt, and transmission of child pornography over the While executing the search warrant at the apartment, your Affiant and SA Eric Barlow interviewed David Carbonaro, who resided at the apartment. During the course of this interview, computer forensics agent, Special Agent Joseph Purfield made your Affiant aware that there were at least two photographic images and one video of a young female approximately three (3) years old on a digital camera located in Carbonaro's bedroom. These images depicted the young girl nude from the waist down and also showed her nude chest. There was also a video of the same girl approximately three (3) years old getting undressed to completely nude while sitting on a bed. These images and video were found on a blue Sony Cybershot digital camera that was located in Carbonaro's bedroom. Carbonaro explained that the video was taken by him and Carbonaro identified the three year (3) old by name to your Affiant. Your Affiant will identify the three year old girl depicted in the video and photos mentioned above as victim hereinafter. Carbonaro identified the victim as the daughter of Carbonaro's ex-girlfriend, Kayla Parker. Carbonaro explained that he lived with the victim and Parker two years ago and that they all lived at the 7201 Bradford Road. Apt. D207 in Upper Darby. Your Affiant was also able to preliminarily review the images and video of the victim on scene and confirm that the photos and video depict the victim engaged in prohibited sexual acts as defined in 18 C.S. § 6312, in violation of the Pennsylvania Crimes Code Section 6312(b), a felony of the second degree.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

As a result of this interview and the forensic review Carbonaro was arrested for the possession, distribution and manufacturing of child pornography.

On August, 08/27/18, your Affiant reviewed all the images and videos found on the blue Sony Cybershot. There were a total of one hundred fifty-nine (157) images of the victim clothed in different levels of undress. Carbonaro described these images as a "photo shoot". In addition to those images, there were eight (9) images and one (1) video of the victim fully or partially nude. One of the images Your Affiant viewed was the victim sitting with an adult female. In this picture, the adult female's hand reaching inside of the victim's underwear, in the front of the victim's underwear, and the hand appears to be touching the victim's genitalia.

Further review of the blue Sony Cybershot showed numerous images of Kayla Parker, the victim's mother. Your Affiant was able to compare the images of Parker that showed her arm and the above described image of the arm reaching into the victim's underwear. After gathering this information, your Affiant contacted the Ohio Office of Attorney General and requested that special agents interview Parker in reference to this investigation.

On September 18, 2018, at approximately 1200 hours, Special Agent John Rodriguez and Special Agent William Jones with the Ohio Office of Attorney General's Bureau of Criminal Investigation (BCI) made contact with Parker at her residence located at 2319 S. Smithville Rd, Dayton, Ohio. Special Agent Rodriguez informed Parker of the investigation involving the victim and requested Parker to provide information. Parker agreed to meet Special Agent Rodriguez and Special Agent Jones at the Dayton Police Department 2nd District sub-station located at 2721 Wayne Ave, Dayton, Ohio. Once arriving at the station, K. Parker was escorted to an interview room, Special Agent Rodriguez informed Parker this is a criminal investigation and explained that Ohio BCI had been requested to conduct the interview regarding the allegations involving the victim. Special Agent Rodriguez informed Parker of her right to have an attorney present during this interview and the instructions regarding her Miranda Rights were read from a prepared text from an Ohio BCI Miranda Waiver form.

At the conclusion of being advised of her rights, Parker was asked her level of education and if she had any difficulty understanding her rights as explained by Special Agent Rodriguez. Parker reported she was a high school graduate with the ability of reading and writing. Parker reviewed the Miranda Waiver form provided by Special Agent Rodriguez and signed and dated the document and agreed to give a statement without having a lawyer present for this interview.

Parker reported that she was contacted by the Ohio Department of Children and Family and was informed there was an ongoing investigation involving David Carbonaro in Pennsylvania. Parker reported Carbonaro had been in possession of inappropriate images of the victim, who she identified as her child. Parker reported that she lived with Carbonaro, the victim and a second child while in Pennsylvania. She identified the 7201 Bradford Road Apartment D207, Upper Darby apartment as an apartment she shared with the victim and Carbonaro.

Parker reported that during the time she lived with Carbonaro, Carbonaro had her commit inappropriate sexual acts with the victim. Parker reported that on numerous occasions Carbonaro would have her undress the victim, and Parker would escort the victim to a bedroom where Carbonaro was waiting. Parker would then shut the door after the victim had entered the bedroom. Parker claimed that she never witnessed the victim being sexually abused, but explained she was certain Carbonaro was entered the bedroom. Parker claimed that she never witnessed the victim being sexually abused, but explained she was certain Carbonaro was acting inappropriate with the victim. When asked if she had ever reported the abuse to anyone, Parker stated that she had not.

Parker was shown the above described photograph of the female hand touching the victim's genitalia and she replied that her hand, which was cropped from the photograph "was south" where it shouldn't have been on the victim. Parker identified the victim in the photograph as her daughter. It should be noted that the victim depicted in the photo was approximately three years old when the photo was taken. Parker was asked what she meant by her hand was "south." Parker reported she had placed her hand inside of the victim's underwear. Parker reported she was told by Carbonaro to put her hand on the victim and she had done this on more than one occasion. According to Parker, Carbonaro would watch her abusing the victim and often masturbate during the act. Parker could not recall when the last incident took place, but she was certain that it occurred while she was residing with Carbonaro at 7201 Bradford Rd, Apt 207 Upper Darby, Pennsylvania.

Parker reported she lived with Carbonaro for approximately one year. Parker reported she had been living in Ohio for approximately four years and had not had contact with Carbonaro since relocating to Ohio. When asked why she had not reported what had occurred in Pennsylvania, Parker reported she was in fear of getting in trouble. Kayla Parker agreed to write an apology letter to the victim. In the letter, Parker apologized for the abuse perpetrated on the victim. The letter was signed and dated by Kayla Parker and turned over to Special Agent Rodriguez at the conclusion of the interview.

On September 25, 2018 SA Rodriguez and SA Andrea Kinzig responded to 2319 S. Smithville Rd. This interview took place in SA Kinzig's vehicle, the doors were unlocked and Parker was advised that she was free to leave at any time. Parker was advised that she had the right not to answer questions regarding this investigation and she was not being taken into custody following the conclusion of this interview.
