- A. Your Affiant, who is employed as a Special Agent for the Pennsylvania Office of Attorney General, Insurance Fraud Section, Western Regional Office, located at 1251 Waterfront Place, Pittsburgh, PA 15222, and who has been so employed since February 13, 2006, is the case agent assigned to the investigation involving the Actor, Melissa Riggle.
- B. The investigation of the Actor was initiated by the Western Regional Office of the Insurance Fraud Section of the Office of Attorney General based upon a referral of information to this office by Rick Shaheen from Giant Eagle Pharmacy Security Department.

On 4/7/18 Sylvia Marino attempted to fill a prescription of Norco 7.5/325 #60 at the Giant Eagle Pharmacy in Leechburg. Giant Eagle pharmacist, Dan Hogue, telephoned the medical office of the purported prescriber, Dr. Elliot Michel, to verify the prescription. Dr. Michel denied writing or authorizing the prescription. Hogue informed Shaheen of the incident.

After receiving the information, Shaheen spoke with Dr. Michel via the telephone in regard to the fraudulent prescription. Dr. Michel informed Shaheen that he has not seen Sylvia Marino as a patient in six years and has not authorized/prescribed her prescriptions since she was a patient. Dr. Michel did verify that her husband, Robert Marino, is a patient of his and that he does prescribe for him. Shaheen informed Dr. Michel that he would be referring the matter to the Attorney General's Office.

- C. On 6/1/18 your Affiant interviewed Dan Hogue and he provided the following information:
 - 1. Hogue is a Registered Pharmacist. He is employed at the Giant Eagle Pharmacy located in Leechburg.
 - 2. Fake prescriptions were discovered on 4/7/18 for patients Jessica Hornyak and Sylvia Marino. Marino dropped off a prescription for her daughter (Jessica Hornyak) for Hydrocodone/APAP 7.5/325mg on 4/7/18 and asked to wait on the prescription. After Hogue viewed the prescription, he realized it was too early to fill the prescription, and Dr. Michel did not put his DEA number on the hard copy.
 - 3. Hogue called Jessica Hornyak to let her know the pharmacy could not fill it until Monday and the pharmacy needed information from the prescribing doctor. About two hours later, Hogue received a phone call from a blocked number stating that it was Sylvia Marino from Dr. Michel's office calling to verify a prescription that the pharmacy had an issue with. Hogue was skeptical because he had not reached out to Dr. Michel's office since it was Saturday. Marino gave Hogue the DEA number for Dr. Michel and asked if everything was ok with the prescription. Hogue said that it will be good, but he could not fill it until Monday because based on her previous fill it was too early by pharmacy standards to fill that day. Marino said ok and hung up. The next morning Hogue opened the pharmacy on Sunday and received a message on the pharmacy's doctor message line. It was Sylvia Marino from Dr. Michel's office calling a prescription in for Jessica Hornyak. The Actor called in an anti-nausea medication and at the end of the message she stated that it was "OK" to fill Hornyak's Norco prescription today, instead of on Monday, per Dr. Michel. Later in the day, Sylvia Marino arrived at the pharmacy to pick up Hornyak's prescriptions, but the pharmacy did not have the Norco prescription ready. Hogue walked over to her at the drive through and told her that he would not take the "OK" from her on the weekend and if Dr. Michel wanted him to fill it early he can call himself and give Hogue the reason why the pharmacy should fill it early. Later in the day, Marino came in to pick up the hard copy of the prescription to take it elsewhere and the pharmacy gave it back to her.
 - 4. On the following Monday, Hogue called Dr. Michel's New Castle office, instead of his Tarentum office, hoping he would be able to talk to someone other than Marino, since she worked as a nurse at the Tarentum office. Hogue got a hold of someone and asked to talk to Dr. Michel. Dr. Michel was very short with Hogue when he asked him if Jessica Hornyak was a patient of his and if he was ok with her mother (Sylvia Marino) authorizing early fills and calling in new prescriptions on his behalf. Dr. Michel stated that it was ok to fill Jessica's prescription early and he will have a word with Marino. Hogue then asked Dr. Michel if Sylvia Marino was a patient of his and he said she was not. Hogue told Dr. Michel according to pharmacy records he had been writing Hydrocodone and Oxycodone prescriptions for Marino for a few years now. Dr. Michel said he would have to review his records and get back to the pharmacy. Later in the evening, the office manager from Dr. Michel's office called the pharmacy and talked to another one of the pharmacists. Hogue believed her name was Melissa. The office manager stated that the prescriptions were fakes and she wanted all of the records that the pharmacy could give her. The pharmacy let her know that the pharmacy

would have to talk to their loss prevention department and have them get her the information. The pharmacy reached out to Rick Shaheen from the Giant Eagle Pharmacy Security Department, so that he could compile the information for them.

- D. Your Affiant interviewed Dr. Elliot Michel on 6/22/18 and he provided the following information:
 - 1. Dr. Michel hired the Actor as a Medical Assistant at Valley Neurological Inc. in 2014.
 - 2. Dr. Michel saw the Actor as a patient just one time on 4/7/14 when she first started working at his medical practice. The Actor complained of migraine headaches. On that day, per the Actor's medical chart, she listed Prozac, Ativan, and birth control as medications that she was currently on at that time. She listed Excedrin Migraine, Advil, Sumavel, Zipsor and Medrol Dosepak as other medications that she had tried, but was not currently on.
 - 3. Dr. Michel prescribed the Actor Topimax for headaches and Prednisone. Dr. Michel never prescribed and/or authorized Xanax (Alprazolam), Norco (Hydrocodone) and Adipax prescriptions for the Actor.
 - 4. The Actor never asked Dr. Michel for prescriptions of Xanax or Norco. Dr. Michel never had a conversation with the Actor about Norco (Hydrocodone) and he never knew she had ever taken it. Dr. Michel said that through conversations at his office, he was aware that the Actor was prescribed Xanax from her primary care physician. However, the Actor never asked him to prescribe her Xanax. Also, Dr. Michel did not prescribe the Actor Adipex, and he did not recall any conversations with her about that drug. Dr. Michel said that he saw and worked with the Actor on a daily basis and that she never asked for prescriptions for herself.
- E. Your Affiant interviewed Sylvia Marino on 6/20/18 and she provided the following information:
 - 1. Marino has been working as a Registered Nurse (RN) for thirty one years. She has been employed at Dr. Elliot Michel's medical office, Valley Neurology Inc. (VNI), as an Infusion Nurse since 2011.
 - 2. Marino had been writing and providing the Actor prescriptions for Norco, and Xanax each month for the past two years and prescriptions of Adipex once in a while. Marino said that the Actor suffered from migraines. The Actor was going through marital problems and a divorce and that is why Marino agreed to write the prescriptions for her. Marino said that the Actor knew that the prescriptions were not authorized by Dr. Michel. No one at the office was aware of what the Actor and Marino were doing. Marino never told the Actor that she was also writing prescriptions for herself.

- 3. Marino said that each month after the Actor would get the prescription of Norco filled, she would give 10 or more to her. The Actor also gave Marino 4 or 5 Xanax each month, after getting that prescription filled. Marino said that the Actor placed the tablets in an unmarked pill bottle and gave them to her at work. Marino stopped writing prescriptions for the Actor at the end of March after being confronted in April by Dr. Michael for writing fraudulent prescriptions.
- F. On 6/20/18 your Affiant interviewed the Actor and she provided the following information:
 - 1. The Actor has been employed as a Medical Assistant at Dr. Michel's office (Valley Neurological) for the past five years.
 - 2. The Actor said that she suffers from migraine headaches. The Actor was in a bad marriage and went through a difficult divorce. The Actor continues to have difficulties with her ex-husband over custody issues of her nine year old daughter.
 - 3. The Actor had been getting prescriptions of Norco, Xanax, and Adipex from Sylvia Marino for a couple years. The Actor said that she did see Dr. Michel as a patient when she first started at the medical practice and he personally wrote her prescriptions at that time. The Actor said that she has not seen Dr. Michel as a patient for several years. The Actor said that she would see and work with Dr. Michel on a daily basis. The Actor did not speak with Dr. Michel about making an appointment to see him or about prescribing her medications. The Actor said that she did not know why she did not directly ask Dr. Michel for the prescriptions.
 - 4. The Actor said "I know it sounds stupid, but I thought he knew". The Actor said that she thought Dr. Michel was "OK" with how she was getting the prescriptions. The Actor said that she knows in order to obtain a narcotic prescription that it has to be given to the person by the doctor at a medical appointment. The Actor was asked again why she did not go directly to the doctor. She replied "I don't know". The Actor said that she knew that Sylvia Marino writing the prescriptions was against the law and that she would not have done it herself.
 - 5. The Actor said that she had the prescriptions filled at the Giant Eagle in New Kensington and paid for them with her UPMC Insurance. The Actor said that each month after getting the prescriptions filled that she gave Sylvia Marino 1 or 2 Xanax pills and a few Norco pills (not sure how much).
- G. Henry Passerrello of Giant Eagle Pharmacy provided Affiant McKee with the following information:
 - 1. A patient profile for the Actor and prescriptions which were filled for her at the Giant Eagle Pharmacy. The following chart delineates the prescriptions purportedly prescribed by Dr. Elliot Michel:
