Charge 1, 6318(A)(1) continuation

During the month of January 2019, the defendant did intentionally contact a minor, or a law enforcement officer acting in the performance of his duties who had assumed the identity of a minor, for the purpose of engaging in the activity of any one or more of the activities prohibited in Chapter 31 of the Crimes Code, namely, Involuntary Deviate Sexual Intercourse, 18 Pa.C.S. §3123(a)(7), and either the person initiating the contact or the person being contacted was within this Commonwealth; to-wit: Defendant, an adult male, did contact an undercover agent of the Pennsylvania Office of Attorney General who was posing as a 14 year old female for the purpose of engaging in oral sex and arranged a time and location to meet the 14 year old female, in violation of the Pennsylvania Crimes Code, Act of December 6, 1972, 18 Pa.C.S. §6318(a)(1), as amended.

Charge 2, 6318(A)(4) continuation

During the month of January, 2019, the defendant did intentionally contact a minor, or a law enforcement officer acting in the performance of his duties who had assumed the identity of a minor, for the purpose of engaging in the activity of any one or more of the activities prohibited in the Crimes Code, namely, Obscene and Other Sexual Materials and Performances, 18 Pa.C.S. §5903(c)(1), and either the person initiating the contact or the person being contacted was within this Commonwealth; to-wit: The Defendant sent nude photographs of himself, including a photo of his penis, to an undercover agent of the Pennsylvania Office of Attorney General who was posing as a 14 year old female, in violation of the Pennsylvania Crimes Code, Act of December 6, 1972, 18 Pa.C.S. §6318(a)(4), as amended.

Charge 3, 5903(c)(1) continuation

During the month of January, 2019 the defendant did knowingly disseminate by sale, loan or otherwise explicit sexual materials to a minor, or a law enforcement officer acting in the performance of his duties who had assumed the identity of a minor in violation of Obscene and Other Sexual Materials and Performances, 18 Pa.C.S. §5903(c)(1), and either the person initiating the contact or the person being contacted was within this Commonwealth; to-wit: The actor intentionally contacted a minor, namely a law enforcement officer acting in an undercover capacity that in the performance of his duties had assumed an identity of a 14 year old female, and sent nude photographs of himself, including a photo of his penis, to the purported minor. The actor did so after acknowledging the age of the purported minor.

Charge 4, 6312(b)(2) continuation

Between April 2018 through May of 2018, the defendant did knowingly photograph, videotape, depict on the computer or film a child under the age of 18 years engaging in a prohibited sex act or in the simulation of such an act; to wit the Defendant knowingly photographed, videotaped a seventeen year old female engaged in deviate sexual intercourse, in violation of the Pennsylvania Crimes Code Section 6312(b), a felony of the first degree, and the photographs and videos depicted this child engaged in prohibited sexual acts.

Charge 5, 6312(d) continuation

Between April, 2018 through January, 2019, the defendant intentionally viewed and/or knowingly possessed or exercised control over any slide, photograph, film, videotape, computer depiction or other material depicting a child under the age of 18 years engaging in a 'prohibited sexual act' or in the simulation of such act, as defined in this section; to wit: Defendant used a communication facility to obtain, view, control and otherwise possess videos of a seventeen year old female engaged in a prohibited sexual act and depicting indecent contact with the child, in violation of the Pennsylvania Crimes Code Section 6312(d), a felony of the second degree.

Charge 6, 6312(c) continuation

Between April, 2018 through January, 2019, the defendant knowingly sold, distributed, delivered, disseminated, transferred, displayed, or exhibited; or possessed for the purpose of sale, distribution, delivery, dissemination, transfer, display, for exhibition for others, any book, magazine, pamphlet, slide, photograph, film, videotape, computer depiction, or other material depicting a child under the age of 18 years engaging in a prohibited sexual act or in the simulation of such act, to wit: Defendant used a communication facility to upload onto a website for the exhibition for others, videos of a seventeen year old female engaged in a prohibited sexual act and depicting indecent contact with the child, in violation of the Pennsylvania Crimes Code Section 6312(c), a felony of the second degree.

Charge 7, 7512 continuation

During the month of January, 2019, the defendant did use a communication facility, as defined in this section, to commit, cause or facilitate the commission of, or an attempt thereof, of any crime which constitutes a felony under Title 18 of the Pennsylvania Crimes Code, to-wit: the defendant did use a computer, cellular phone, and/or other electronic device and the internet to commit any of the felony crimes described in greater detail in the other charges herein, in violation of the Pennsylvania Crimes Code, Act of December 6, 1972, 18 Pa.C.S. §7512(a), as amended.

AFFIDAVIT of PROBABLE CAUSE

Daniel Block is a Special Agent with the Bureau of Criminal Investigations of the Pennsylvania Office of Attorney General and is currently assigned to the Child Predator Section. He has been investigating internet crimes against children since December of 2012. He has attended training courses that have focused on sexual offenses against children including computer based offenses. To date, he has actively participated in numerous investigations throughout the Commonwealth of Pennsylvania dealing with online solicitations for sexual offenses and/or attempted sexual offenses with minors in addition to unlawful contact with minors, sexual abuse of children, and criminal use of communications facilities. He is also a Task Force Officer with Homeland Security Investigations Child Exploitation/Trafficking Group. Prior to the current position of Special Agent, your Affiant worked uniform patrol (starting in 1999) for the St. Louis County Police Department, St. Louis Missouri, additionally your Affiant worked as a Risk Management advisor for a large disaster relief organization. Your Affiant has conducted international criminal investigations, including kidnappings, and crimes of violence against children.

Your Affiant's duties include investigating violations of state law, such as the online exploitation of children. In particular, violations of Title 18, Section 6312, that criminalizes the possession, receipt, and transmission of child pornography and violations of Title 18, Section 6318 (b.1)[to pro-actively conduct investigations involving child predators who wish to engage in sexual activity with minors].

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

Trooper Ryan Seiple, is a sworn law enforcement officer of the Pennsylvania State Police currently assigned to the Criminal Investigation Unit at the Pennsylvania State Police (PSP) Belfast Station. While working as a Pennsylvania State Trooper and more specifically, while working in the capacity of a Criminal Investigator, he is tasked to investigate sex crimes pertaining to but not limited to rapes, indecent assaults, and sexual abuse of children.

This investigation involves an adult male who is known as "JOSHUA PADILLA", hereinafter the Actor, who is alleged to have had unlawful contacts, via a communication facility, with a female minor and a purported female minor who was in Northampton County, Pennsylvania, for the purpose of enticing the minor in prohibited/unlawful sexual activity.

On October 25, 2018 at approximately 12:15pm, Trooper Seiple received a Childline Report of Suspected Child Abuse and Neglect.

On October 26, 2018 at approximately 11:40am, Trooper Seiple interviewed the MLS, hereinafter the Victim, at PSP Belfast. After the interview on October 26, 2018, Trooper Seiple also spoke to the Victim numerous times on the phone and conducted a subsequent interview with her at PSP Belfast. During the course of the interviews, it was ascertained that the male Actor and the Victim arranged a sexual encounter which entailed vaginal intercourse. The Victim described the sexual encounter to take place during the last week of April, 2018 or maybe the first week of May, 2018. It should be noted that the victim's date of birth is 07/08/2000 and she was 17 during the commission of these sex acts. At this time, the male Actor picked the Victim up in a car at the Belvidere Library which is located in Belvidere, New Jersey. They then drove to a location off River Road which is located in Upper Mount Bethel Twp., Northampton County.

The Victim stated that the she and the Actor engaged in sexual intercourse while at the location off of River Road, Upper Mount Bethel Twp., Northampton County. The Victim also stated that the Actor performed anal and oral intercourse on her at this location.

The Victim related the actor used his cell phone to video record portions of the aforementioned sexual encounter. During the course of this interview with Trooper Seiple, the Victim related that the male actor has some of her videos on his "adultfriendfinder" page. It should be noted that the victim's date of birth is 07/08/2000, and she was 17 at the time the sex act was recorded during the last week of April, 2018 or the first week of May, 2018.

The victim described the actor to be about 5'4-5'5. She related the Actor said his age was thirty (30) and she related to the Actor that she was seventeen (17). She was asked how he knew she was 17 and she said because he asked her what her real age was.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

The Victim allowed Trooper Seiple to access her account on adultfriendfinder.com. While on the account Trooper Seiple viewed various messages between the Victim and the Actor. The Victim was identified as "petthekitty99" as where the Actor was identified as "5Oshafesoffun". On September 12, 2018, the Actor stated to the victim, "when are you turning 18? What's your number let me text you". After this message, on September 12, 2018, the Victim asked the Actor to send her the videos he took of her. On September 18, 2018, the Actor told the Victim on adultfriendfinder that he sent the videos to her.

On January 9, 2019, Trooper Seiple logged onto the Victim's adultfriendfinder account and assumed the identity of the Victim. At approximately 10:45am, the Actor initiated a conversation with the Victim's adultfriendfinder account (Trooper Seiple). Trooper Seiple, purporting to be the Victim, engaged the Actor in a conversation where the Actor provided a phone number of "(732) 629-8514" and requested that the Victim text him. The Actor used sexually explicit language and asked when he and the victim could meet up again.

On January 9, 2019, while conversing with the Actor via text message with phone number (732) 629-8514, the Actor asked, "You turn 18 yet?" and requested a "sexy pic" from the Victim. At one point Trooper Seiple told him the purported victim was working and asked the Actor if he could come to Nazareth. He asked "What kind of job? Sneak into the bathroom real quick and send a pic of your nipples?" "I might be able to. Will your friend come too and we all drink and get a room?" "How old is she? (Your friend)". The conversation briefly continued and within that conversation Trooper Seiple advised the Actor "the friend" was 15 years old. After advising the Actor that the friend was 15 years old, the Actor asked "Any pics of her?"

Following the above conversation with the Actor, Trooper Seiple contacted your Affiant.

Your Affiant, Special Agent Block, requested that Trooper Seiple provide the Actor his (SA Block's) phone number, 908-624-3018, and to tell the Actor that the Victim's friend's name was Marissa.

On January 9, 2019 at approximately 2:10pm, Trooper Seiple again logged into the Victim's account and while purporting to be the Victim, provided the Actor the juvenile's name of Marissa with a phone number of 908-624-3018.

After providing the Actor said information, the Actor proceeded to have text base conversations with your Affiant, SA Block, who was purporting to be 14-year-old female child, Marissa on multiple occasions during the text message exchange with the Actor. Between January 10, 2019 and January 16, 2019, over text messages and over the Kik messaging application, after being advised that he was speaking with a 14 year old female child, the Actor expressed wanting to meet with the purported child. The Actor used sexually explicit language, sent the purported child two images of a penis, and requested pictures of the purported 14 year old female child. The text message conversations with the Actor on (732) 629-8514 continued at various dates and times between January 10, 2019 and January 11, 2019. The Actor asked to meet with the purported child and after the purported child told the

Actor she was 14 years old, the Actor requested oral sex by saying "Show daddy those lips that I'm going to kiss and have around my dick" on January 10, 2019 at approximately 4:22pm over text message. The Actor then stated on the same date at 4:28pm that he wanted to "rub" her "pussy" on his "big dick" and sent the purported child a photo of his nude penis. Also, on January 10, 2019 at 7:00am, the Actor told the purported 14 year old child that he likes "kissing, hair pulling, choking, spanking." On January 10, 2019 at 7:34am, the Actor requested to see the purported child's "ass" without her pants on and requested to rub the purported child's butt without her pants on. The Actor requested photos of the child and requested to meet the purported child after requesting to perform various sex acts on the purported child. On January 11, 2019 between 6:20am and 8:08am the Actor messaged the child and requested photos of the child in school. During the aforementioned text exchange between the Actor and your Affiant. Your Affiant received a total of four (4) images from the Actor, of the Actor. The images depicted a Hispanic male, approximately in his late 20s early 30s with distinct tattoos on his left arm shoulder and chest area, as well as his right forearm.

On January 10, 2019 at approximately 4:55pm, the Victim, Special Agent Fallon from the Pennsylvania Office of the Attorney General's office, and Trooper Seiple, viewed the Actor's adultfriendfinder account. His account reflected a username of "5Oshadesoffun" and depicted various videos. In viewing videos which were posted on his account, the Victim identified one of the videos to be her and the said Actor. Trooper Seiple viewed this video. The video depicted a male having anal sex with a female (identified as the Victim) and had a heading of "young girl first anal". It should be noted that the video of the victim posted by "5Oshadesoffun" is available to be seen by other online users of adultfriendfinder.com. Under the aforementioned video, Trooper Seiple noted that the video of the Victim was uploaded to adultfriendfinder on June 10, 2018, it had 214 views, 3 comments and had 19 member "likes." It should be noted that the victim identified in the aforementioned video did not turn eighteen (18) until 07/08/2000, almost one month after the video was uploaded to adultfriendfinder.com.

On January 11, 2019, at 8:08am, the Actor began messaging the purported child (SA Block) on the message application, Kik. The Actor used the screenname/username nygfan210 on Kik. The Actor messaged the purported minor at various dates and times on Kik between January 11, 2019 and January 16, 2019. The Actor requested to meet the purported child during this time frame. On January 11, 2019 at 10:26am, the Actor requested more "pics" from the purported child and told the child "daddy wants to rub my hands all over your body." Also on January 11, 2019 on the Kik application, the Actor stated to the purported child at 4:24pm. "I want my cum all over you baby." On January 13, 2019, the conversation continued on Kik and the Actor requested more "pics" of the purported child. At 12:27am on January 13, 2019, the Actor stated that he wanted to be in bed with the purported child. On January 13, 2019 at 12:59pm, the Actor stated "Send daddy. New pic baby." On January 14, 2019, after requesting more photos of the purported child, the Actor stated at 8:18am "you are young, I don't want to get in trouble. So I want to know youre serious before anything."

An intelligence inquiry into the number (732) 629-8514, the phone number the Actor was using to communicate with the purported minor children about sexual acts, revealed that it came back to Bandwidth.com, Inc.

In summary, the Actor communicated with a purported minor child about having sexual relations, including oral sex, with the purported fourteen year old minor child utilizing phone number (732) 629-8514, in violation of Unlawful Contact with a Minor, 18 Pa.C.S. § 6318(a)(1), § 6318(a)(4), and Obscene and other sexual materials and performances, 18 Pa.C.S. § 5903(c)(1). That phone number, (732) 629-8514, is registered to Pinger, Inc and has a username of jpadilla8017 associated with phone number (732) 629-8514. According to Pinger Inc., phone number (732) 629-8514 utilized IP address 73.150.109.41 on multiple dates and times between January 10, 2019 and January 15, 2019. On January 11, 2019, between 2:40am and 11:55am, Pinger IP logs show the actor accessing Pinger from an electronic device using IP address 73.150.109.41 numerous times between midnight and 12:05pm. Specifically, Pinger was accessed from an electronic device using IP address 73.150.109.41 thirteen times between 2:40am and 11:55am on January 11, 2019. On the same date, January 11, 2019 between 6:20am and 8:08am, the Actor messaged the purported child by text message, requesting photos from the purported child, and requesting the purported minor talk on the phone.

In summary, the Actor created an Adultfriendfinder.com account under the username of "50Shadesoffun". This adultfriendfinder account "50Shadesoffun" posted a video on the internet on June 10, 2018 which contained the Victim, a person under the age of eighteen, engaged in sexual acts, including anal sex, in violation of Sexual Abuse of Children, 18 Pa.C.S. § 6312(b), § 6312(c), § 6312(d). A posting of the video was on the adultfriendfinder website under the username of "5OshadesofFun" on October 26, 2018 when Trooper Seiple copied a still image of its posting during his interview with the Victim. It should be noted that the IP logs provided by adultfriendfinder.com show that IP address 73.150.109.41 accessed adultfriendfinder three times between 9:26am and 9:47am on October 26, 2018. The posting of the video was also on the adultfriendfinder website under the username of "5OshadesofFun". The posting and the video was viewed by Trooper Seiple on January 10, 2019. The posting was subsequently replicated and printed. It should be noted that on January 10, 2019, IP address 73.150.109.41 accessed adultfriendfinder three times between 4:24pm and 5:59pm on January 10, 2019. This same IP address, 73.150.109.41, was provided by Comcast at the residence of 3 Berkeley Place, Eatontown, NJ and registered to Joshua Padilla between August 18, 2018 and January 13, 2019.

On the upload date of the video on June 10, 2018 as well as on October 26, 2018 and on January 10, 2019 when the video was seen on adultfriendfinder by Trooper Seiple, IP address 73.150.109.41, located at 3 Berkeley Place, Eatontown, NJ, accessed adultfriendfinder.com under the username of "5OshadesofFun." For the aforementioned reasons, your Affiant has probable cause to believe that that the video of the child Victim engaged in sexual acts posted on the website under the username "5OshadesofFun", under the title "young girl first anal" in violation of Sexual Abuse of Children, 18 Pa.C.S. § 6312(b), § 6312(c), § 6312(d), was in the possession and control of the 5OshadesofFun adultfriendfinder account that was being accessed by an electronic device at IP address, 73.150.109.41 at 3 Berkeley Place, Eatontown, NJ that was registered to Joshua Padilla between August 18, 2018 and January 13, 2019.

In summary, the Actor corresponded using a Kik account under the name of "nygfan210" with a purported minor child about having sexual relations with the purported minor child (your Affiant), in violation of Unlawful Contact with a Minor, 18 Pa.C.S. § 6318(a)(1). According to Kik, the username "nygfan210" utilized IP address 73.150.109.41 on multiple dates and times between December 21, 2018 and January 14, 2019.
