AFFIDAVIT of PROBABLE CAUSE

AFFIANT BACKGROUND

Your Affiant, Natalie DeAngelo #502, sworn Special Agent with the Pennsylvania Office of Attorney General (PAOAG), Bureau of Criminal Investigations, Organized Crime Section, located at 1000 Madison Avenue, Suite 310, Norristown, Pennsylvania 19403. Your Affiant has conducted and/or assisted in numerous investigations, including, but not limited to corrupt organizations, theft, and fraud. Your Affiant has received training in electronic surveillance by the Pennsylvania State Police. This training resulted in the issuance of a class "A" certification, authorizing your Affiant to conduct criminal investigations using various wiretapping equipment, as authorized by Chapter 57 of the Pennsylvania Crimes Code. Your Affiant has experience in wiretap investigations as Affiant and surveillance. Your Affiant has prepared affidavits of probable cause that supported wiretap applications as well as wiretap progress reports. Your Affiant has been involved in the interpretation and transcription of intercepted telephone calls in wiretap investigations. Your Affiant has listened to, and interpreted, the contents of intercepted telephone conversations related to receiving stolen property and other crimes. Your Affiant has been involved in the execution of search and seizure warrants, interviewing/debriefing defendants, and the implementation of arrests. As a result of my training and experience, I am familiar with the methods, devices, and modus operandi of persons and organizations involved in receiving stolen property and other theft related offenses. I am an investigative or law enforcement officer of the Commonwealth of Pennsylvania within the meaning of The Pennsylvania Crimes Code.

Your Affiant is empowered to conduct investigations of and to make arrests for offenses that fall within the Commonwealth Attorneys Act. The probable cause listed in this Affidavit is based upon physical surveillance, covert surveillance, and information from other members of Bureau of Criminal Investigations, Organized Crime Section, and other Law Enforcement Officers and Agencies.

As a Special Agent of the Office of Attorney General, Bureau of Criminal Investigation, Organized Crime Section, your Affiant is empowered by law to conduct investigations of, and to make arrests for, offenses involving

There is probable cause to believe that Myra Reddy (DOB:4/5/1964), Belinda Cooper (DOB:1/22/1983), Latoya Donaldson (DOB:11/11/1985), Zabriah Whitmore (DOB:7/25/1994), and others, as yet unknown, have committed and are committing offenses involving Corrupt Organizations, 18 Pa.C.S. §911(b); Identity Theft, 18 Pa.C.S. §4120; Theft by Unlawful Taking, 18 Pa.C.S. §3921(a); Retail Theft, 18 Pa.C.S. §3929(a); Organized Retail Theft, 18 Pa.C.S. §3929.3(a); Receiving Stolen Property, 18 Pa.C.S. §3925(a); and Criminal Conspiracy, 18 Pa.C.S. § 903.

PROBABLE CAUSE

The probable cause listed in this Affidavit is based upon physical surveillance, covert surveillance, and information from other members of Bureau of Criminal Investigations, Organized Crime Section, and other Law Enforcement Officers and Agencies.

Your Affiant spoke with Tredyffrin Township (Chester County) Police Officer Michael Cermignano, who informed your Affiant that while he was on duty on March 11, 2018, he stopped a black GMC/Envoy with PA registration KNM-2784 on Northbound 202 in Tredyffrin Township for traffic violations. The vehicle was registered to that of a Jordine Mathis. Myra Reddy, the driver, told Officer Cermingnano that the GMC belonged to her "cousin", Jordine. In the vehicle were Stephon Durand Clark, (hereinafter "Clark") rear passenger, Marquan McPherson, (hereinafter "McPherson") front passenger, and a female later identified as Myra Reddy, (hereinafter "Reddy") driver originally presented a PA license belonging to Tyleah Handy (DOB 2/15/87, 4209 Mantua Avenue, Philadelphia, PA). According to Officer Cermignano he confronted Reddy telling her that she did not appear to match the photo or age of Tyleah Handy. Reddy repeatedly denied her true identity. Her actual identity was later confirmed through fingerprinting.

During a roadside probable cause search of the vehicle, Officer Cermignano observed a "booster bag", which is typically a plastic store bag that is lined with aluminum foil with the intention to prevent a

store alarm from sounding thereby avoiding detection of stolen items inside the bag. Officer Cermignano also observed a few empty purses on the floor of the vehicle. In the back was a new vanity and a box containing dozens of new-in-box door handles. Officer Cermignano also observed a box cutter and a few Honeywell Thermostats. Officer Cermignano located another driver's license in the name of Kandyce Dunlap (DOB 10/31/1998, 1428 West Chew Street, Philadelphia, PA 19141).

Officer Cermignano had the GMC towed to Tredyffrin Township Police Department and secured in their sally-port pending further investigation, and Reddy was placed under arrest for False ID. McPherson and Clark were photographed on scene but were released without charges. During a search incident to arrest of Reddy's purse which she was holding, a PA license belonging to Patricia Kramer (DOB 11/29/51 W/F of 7215 Souder Street, Philadelphia) was found. She also had the social security card of Kandyce Dunlap in her possession, as well as a screw driver and multiple return receipts/gift cards returns from Home Depot in Lancaster which were dated March 11, 2018, the same date as the traffic stop. She also had evidence from a suspected previous theft from Home Depot in Marple Township (Delaware County).

Based on the purses, the items he observed in the vehicle and all of the other individuals' ID's recovered, Officer Cermignano believes that these individuals may have been conducting theft/fraud returns at Home Depots in the area as well as thefts from vehicles. Officer Cermignano also obtained the mobile iPhone belonging to Myra Reddy which was placed in Tredyffrin Township Police Department's evidence prior to it being transferred to the Pennsylvania Office of Attorney General, Organized Crime Section evidence room on May 10, 2018.

On March 12, 2018, a complete search of the GMC was conducted by Tredyffrin Township Police and the results are as follows: Inside of the two big boxes there were 110 total items stuffed inside, which ranged from faucets, electronics, thermostats, LED signs, etc. Officer Cermignano made contact with Bill Adams (hereinafter

"Adams"), Home Depot Corporate Investigator, who identified the subjects as being part of a known "box stuffing" organized retail theft ring. "Box stuffing" is where thieves remove a large item from a box and then stuff the box with smaller, high priced items which, can later be pawned or sold at a higher value. Adams advised he identified Myra Reddy and her booster crew as working in southeastern Pennsylvania, for the last several months. Adams added that he has investigated Myra Reddy and her organized retail theft ring for the past several years. Officer Cermignano provided your Affiant with a copy of all of the receipts and gift cards that were recovered for other stores, such as Toys r' us, H & M, Talbot's etc., by Officer Cermignano. Officer Cermignano also recovered a boost bag, box cutter, wire cutters, and two screw-driver pry bars. Officer Cermignano also located two purses and a pouch, which were empty.

On March 13, 2018, at the request of Officer Cermignano, 16th District Philadelphia Police Officer Brian McCarthy responded to the residence of Tyleah Handy, 4209 Mantua Avenue, Philadelphia, in an attempt to make contact with her in reference to the investigation. At approximately 9:30 p.m. Officer Cermignano received a phone call from Officer McCarthy, who advised Officer Cermignano, he was at the residence with Tyleah Handy and placed her on the phone with Officer Cermignano. Officer Cermignano advised that he spoke with Tyleah Handy for several minutes and she related to Officer Cermignano that her identification was taken while in a bar over a year ago, but she never made a report and has since obtained a duplicate license. Officer Cermignano stated that he asked Ms. Handy if anyone had permission to be in possession and/or use her ID for any purpose in which she stated "no one has permission to use my ID". At the request of Officer Cermignano, Philadelphia Police Officer McCarthy documented this in a Philadelphia Police Report (D.C. #20181610234) which Tyleah Handy signed. The same request was made by Officer Cermignano to 2nd District Philadelphia Police Lieutenant Nicholas Schneider requesting that he or another 2nd District Officer attempt to make contact with Patricia Kramer at her residence of 7215 Souder Street, Philadelphia, PA in reference to this investigation. Officer Schneider advised Officer Cermignano that he was handling the request. On March 16, 2018 Officer Cermignano received a phone call from Patricia Kramer. Ms. Kramer advised Officer Cermignano that she believed her wallet, containing her license, credit

cards, insurance cards, keys, and a small amount of cash, was lost or stolen while shopping at the Dollar Store around the corner from her residence sometime in January 2018. Ms. Kramer also stated she never reported it to the Philadelphia Police. Officer Cermignano asked Patricia Kramer if anyone would have possession of and/or permission to use her ID for any purpose, to which Ms. Kramer stated, "no".

On Tuesday, March 20, 2018, at the request of Officer Cermignano, 35th District Philadelphia Police Officer Tony Comitalo responded to the residence of Kandyce Dunlap, 1428 West Chew Avenue, Philadelphia, PA, in an attempt to make contact with her in reference to this investigation. At approximately 6:24 p.m., Officer Cermignano received a message from Officer Comitalo providing information from Kandyce Dunlap's mother that Dunlap now resided in Atlanta. Comitalo then provided Officer Cermignano Dunplap's phone number. Officer Cermignano called and spoke with Kandyce Dunlap for several minutes and she provided information that her wallet containing her identification card was lost approximately two years ago, but she did not make a report. Officer Cermignano asked Ms. Dunlap if anyone had permission to be in possession and/or use her ID for any purpose, she stated no and further provided information that she believed someone had been using her ID for some time, as she had received notices from various agencies regarding citations that were not hers.

On Wednesday, May 30, 2018, at approximately 12:10 p.m., your Affiant obtained a search warrant from Magisterial District Judge Kathleen Rebar for Myra Reddy's white iPhone (IMEI 355837087883241). On Wednesday, May 30, 2018, at approximately 1:17 p.m., Computer Forensics Special Agent Joseph Purfield received the white iPhone (IMEI 355837087883241) OCE-10743. On Thursday, July 26, 2018, at approximately 12:30 p.m., this Special Agent received the Computer Forensics Examination Summary Report and a flash drive containing the contents of the white iPhone (IMEI 355837087883241) seized content from Computer Forensics Special Agent Nicole Whaley. Computer Forensics was able to determine the phone number seized from Myra Reddy as being (267) 367-7791. Your Affiant has reviewed the contents of Myra Reddy's phone and has discovered

a multitude of texts regarding selling store credit for various retailers. The following text conversation is one of many.

Your Affiant submits that this series of text messages below show, Myra Reddy, identifying herself as Grandmom. The text message thread shows, that Myra Reddy is an individual that others reach out to in an attempt to obtain store retail merchandise credit for half the price. In this series of text messages, Myra Reddy is selling a \$500 Home Depot store credit for \$250 or a \$1,000 Home Depot store credit for \$500. Based on your Affiants training and experience, your Affiant believes the alleged booster crew is taking either the items and/or merchandise cards to a fence. A "fence" is an individual who knowingly buys stolen property for later resale. It is evident from this text message thread that Myra Reddy is known to individuals as the individual to go to for retail store credit.

Your Affiant submits that this series of text messages below show, Myra Reddy, identifying herself as Grandmom and 2672303983 identifies himself in a text as "Linard Gay". The text message thread shows that Myra Reddy is an individual that others reach out to in an attempt to obtain store retail merchandise credit for a discounted price. In this series of text messages, Myra Reddy explains how she is selling a \$2000 Home Depot store credit for \$1,200. Telephone number 2672303983, "Linard Gay" sent Reddy multiple stocking keep unit "SKU" numbers after telling her he would be sending her a list. Your Affiant submits that this shows he is telling Reddy what items to get at the store and put an order in using his name for a Home Depot order using store credit obtained through multiple non-receipted refunds. Reddy discusses storage in the below message thread and explains how she can't get anything until her people come back on Tuesday. Your Affiant submits that Reddy is referring to a storage unit which agents discovered during surveillance and covert surveillance. Reddy has been observed at the storage unit on Tacoma and Earlham Terrace St. in Philadelphia, PA 19144, Unit 3, at multiple times which is listed later in this affidavit. Based on your Affiant's knowledge, experience, and education, it is believed that Reddy is referring to picking up stolen merchandise in the storage unit to return at Home Depot for store credit. Reddy also indicates several times how she is "getting her people" and she is "working". Home Depot Corporate Investigator, Adam Van Duzer advised your Affiant that on May 17, 2017, Reddy was in the Home Depot in Woodbridge, NJ purchasing two vanities. Van Duzer has notified your Affiant of a "BOLO - Be On the Look Out" for alert involving Myra Reddy and six others. The "BOLO" provides a synopsis detailing them as a "vanity box stuffing crew - targeting faucets". The alert explains that the crew works as a team between two to five people. At approximately 11:50 a.m. SA Kohler-La Torre observed Myra Reddy exit her residence wearing a camo jacket and black pants and enter the driver side of the black GMC Envoy (PA tag: KNM-2784, VIN#1GKET16S756101461, registered to Jordine Mathis, 3822 North Gratz Street, Philadelphia, PA 19140). The vehicle left the premise. Surveillance units followed Myra Reddy to Home Depot located at 4640 Roosevelt Boulevard, Philadelphia, PA 19124. SA Kohler-La Torre observed two females exit the GMC Envoy and enter the Home Depot. SA Clarke observed Reddy and an unknown black female meet with an older unknown black male in the lumber aisle of the store. SA Clarke observed the three individuals in the store for approximately a half hour before exiting the Home Depot at approximately 12:40 p.m. Surveillance units observed Reddy and the unknown black female enter the GMC Envoy and exit the parking lot. Surveillance units followed Reddy to the Home Depot located at 2539 Castor Avenue, Philadelphia, PA at approximately 12:50 p.m. Also, at approximately 12:50 p.m., the unknown black male observed with Reddy at the Roosevelt Boulevard Home Depot also parked in the Castor Avenue Home Depot in a maroon/red Dodge Ram 1500 (PA tag: ZHG8528), registered to James Massey, 4459 North 17th Street, Philadelphia, PA 19140). Surveillance units identified James Massey through the Pennsylvania Driver License photo as the male observed in the store and driving the Ram 1500. Massey and Reddy parked at the lumber contractor pick-up area of the parking lot. Reddy, Massey, and the unknown black female entered the Home Depot and walked toward the lumber area. Special Agents Clarke and DeAngelo observed the three individuals in the lumber aisle having wood cut by a Home Depot associate. SA Clarke observed Reddy and the unknown black female approach the cashier line. Reddy paid for 18 pieces of oak riser wood using a Home Depot store credit card (based off of a receipt later obtained from Home Depot). Reddy and the unknown black female exited the Home Depot and unloaded the wood along with Massey's assistance and placed the wood into Massey's Page ___ of __

Ram 1500. Reddy and the unknown black female placed three of the 18 pieces of wood back into a Home Depot shopping cart and reentered the Home Depot and walked directly to the lumber aisle. SA Clarke observed Reddy and the unknown black female spend limited time in the lumber aisle before approaching the return cashier service department with five pieces of oak riser wood where they attempted to return all five "5" pieces of wood. The return cashier denied the return of three of the oak risers because they were already cut. Reddy successfully returned two oak risers and committed a theft by receiving approximately \$30 in store merchandise credit through successfully returning two oak risers that she had not paid for. Reddy and the unknown black female exited the store with three oak risers and loaded them into Massey's RAM 1500. SA Kohler-La Torre heard Reddy and the unknown black female discussing how the associate would not accept their return of the three precut oak risers.

At approximately 1:48 p.m. Reddy and the unknown black female entered the GMC Envoy and exited the parking lot. Surveillance units attempted to follow Reddy but eventually lost view after Reddy sped out the area, driving erratically, as if evading being followed and conducting counter surveillance.

Special Agent Clarke spoke to Loss Prevention Manager, David Lebron at the Castor Avenue Home Depot in regard to the theft and events that transpired inside the store by Myra Reddy, James Massey, and the unknown black female. Lebron advised SA Clarke that after speaking with an associate in the lumber aisle, he learned Reddy called the associate a "cracker". Lebron also informed SA Clarke that after speaking with the return cashier who completed the return transaction with Reddy, he learned that Reddy said to the associate she knew someone was following her inside the store and "what, can't black people buy nice things."

Utilizing a covert surveillance camera, at approximately 2:28 p.m., SA DeAngelo observed James Massey park in front of 2415 North Opal Street, Philadelphia, PA. Massey was observed exiting his vehicle, opening the back doors to his Ram 1500 vehicle and open the front door to Reddy's residence. Massey is observed removing wood from the back of his vehicle and carrying it inside the residence of Myra Reddy (2415 North Opal Street, Philadelphia, PA). At approximately 2:35 p.m., the black GMC Envoy arrived and parked on North Opal Street near

2415 North Opal Street. Reddy and the unknown black female exited the vehicle and entered 2415 North Opal Street, Philadelphia, PA with bags in their hand. SA Kohler-La Torre observed Massey, Reddy, and unknown black female at 2415 North Opal Street, Philadelphia, PA.

On December 11, 2018 at 9:30 a.m., the Honorable Robert P. Coleman, Court of Common Pleas, Philadelphia County, PA., issued an Order Authorizing the Installation and Use of a Mobile Tracking Device pursuant to Section 5761 of the Wiretapping and Electronic Surveillance Control Act, 18 PA C.S., for ninety (90) days from the date of installation on the above referenced vehicle. On December 18. 2018, the GPS tracking device was installed on the 2005, Black GMC Envoy, PA registration: KNM-2784. From December 18, 2018 to January 16, 2019, your Affiant has monitored the GPS tracker system that was installed on the target vehicle. On December 18, 2018, at 6:46 p.m., the GPS tracker system located the target vehicle, 2005, Black, GMC Envoy, bearing registration KNM-2784 at 4640 Roosevelt Boulevard, Philadelphia, PA. Home Depot is located at 4640 Roosevelt Boulevard, Philadelphia, PA 19124. Your Affiant observed the GPS tracker system that was located on the GMC Envoy was showing the vehicle to be in the area of North Reese and West Norris Street, Philadelphia, PA on January 4, 2019. On January 7, 2019, SA Justin Clarke observed the target vehicle, GMC Envoy, parked in the vicinity of North Reese and West Norris Street near an Auto Repair shop. Your Affiant has observed the GPS tracker system showing the vehicle to be located near the vicinity of North Reese and West Norris Street from January 4, 2019 through January 15, 2019. Your Affiant has utilized a covert surveillance camera located near Myra Reddy's residence, 2415 North Opal Street, Philadelphia, PA 19132, which has shown a 2019, White Toyota 4-Runner (hereinthereafter "White 4-Runner"), bearing New York registration: GZU-3536 since January 13, 2019.

On January 16, 2019, your Affiant, Special Agent Justin Clarke and Special Agent Gabriel Fabian conducted surveillance at Myra Reddy's residence, 2415 North Opal Street, Philadelphia, PA 19132. At 8:58 a.m., SA Fabian observed the White 4-Runner, GZU-3536, parked near the front door of 2415 North Opal Street, Philadelphia, PA 19132. At 9:45 a.m., SA Fabian observed a dark colored Jeep bearing PA Registration: KPC-0352, registered to

At 9:47 a.m., SA Fabian observed a black female exited 2415 North Opal Street, Philadelphia, PA and opened the trunk of the White 4-Runner. At 9:59 a.m., SA Fabian observed the White 4-Runner depart the vicinity of the residence. Your Affiant, Agent Clarke, and Agent Fabian conducted surveillance of the vehicle. The vehicle was followed to a storage shed labeled "3" located in the 5400 block of Tacoma Street near the intersection of Tacoma Street and Earlham Terrace at 10:17 a.m. The White 4-Runner was observed parked in front of the storage shed labeled "3" with the passenger side door open to the storage unit. Reddy was observed standing in front of the storage unit with the storage unit door open and multiple black trash bags on the ground in between the White 4-Runner and the open storage shed. Investigator, Adam Van Duzer, monitored the security system in Home Depot and observed a black female enter the Home Depot and approach the returns department with a plastic bag filled with items and also held a white faucet box. Van Duzer stated that this black female returned these items without a receipt and presented a Pennsylvania Identification in the name of Zabriah Whitmore. Whitmore successfully returned 4 items totaling \$467.43 which was placed on a Home Depot gift card. After the return was completed, Whitmore returned to the White 4-Runner and the vehicle departed the vicinity of the Home Depot. The White 4-Runner was then followed directly to the Home Depot located at 4640 Roosevelt Boulevard, Philadelphia, PA 19124. Upon arriving at this Home Depot parking lot, a black female later identified as Belinda Cooper exited the White 4-Runner and brought multiple new-in-box items from the White 4-Runner to the returns station. The vehicle was then towed to the Philadelphia Parking Authority parking lot located at 4701 Bath Street, Philadelphia, PA 19137.

Your Affiant, Agent Clarke, and Agent Fabian arrived on the scene and observed multiple new-in-box merchandise scattered throughout the vehicle. Philadelphia Parking Authority provided Agent Fabian a copy of the Avis Rent a Car System Rental Agreement for the 2019 Toyota 4-Runner SUV, white, New York registration: GZU-3536 VIN#JTEBU5JR5K5640388. The rental agreement shows the customer name as LaToya Donaldson and the rental timeframe was from January 11, 2019 through January 18, 2019.

On January 16, 2019, at approximately 7:30 p.m., this agent obtained a search warrant from the Honorable Robert P. Coleman, Court of Common Pleas, Philadelphia County, PA for the 2019 Toyota 4-Runner SUV, white, New York registration: GZU-3536 VIN#JTEBU5JR5K5640388. The items to be searched for and seized in the White 4-Runner are new-in-box merchandise or other merchandise bearing retail tags or identification, receipts, store security devices, store credit card, store gift card, tools or devices commonly used to pry, remove, bend, damage, alter, destroy, or impact force on other objects, such as pry bars, screw drivers, hammers, or other similar items, GPS information contained within the car containing recent destinations, electronic devices, cell phones, laptops, any mail, letters, correspondence indicia of rental agreements, contracts, receipts of rental, illegal narcotics and/or paraphanalia.

At approximately 8:00 p.m., this agent, along with SSA William Ralston, SA Justin Clarke, and SA Gabriel Fabian arrived at the Philadelphia Parking Authority impound lot located at 4701 Bath Street, Philadelphia. PA

Agents seized 20 new-in-box items inside the 2019 Toyota 4-Runner SUV, white, New York registration: GZU-3536 VIN#JTEBU5JR5K5640388, along with a return receipt dated January 7, 2019 in the amount of \$396.09 which was applied to a Home Depot store credit card. Agents also seized 19 Home Depot plastic bags which held several new-in-box items inside them.

On January 17, 2019, this agent requested assistance from Home Depot Investigator, Adam Van Duzer to trace back a return conducted on January 7, 2019 at 7:16 p.m. at the Home Depot located at 7690 Washington Lane, Wyncote, PA 19095. Adam Van Duzer provided your Affiant with store photographs that show the vehicle Reddy arrived in at Home Depot. Van Duzer stated the vehicle was occupied by three, including Reddy. Two occupants exited Reddy's Silver SUV at the entrance of Home Depot and then Reddy entered Home Depot after she parked her vehicle. Van Duzer provided the return transaction which shows the items were returned without a receipt and presented a Pennsylvania identification in the name of Kalishea Reddy. Kalishea Reddy successfully returned 4 items totaling \$396.09 which was placed on a Home Depot store credit card (card# 179104222203). Van Duzer stated that following the refund, Myra Reddy made a purchase of Milwaukee tools, totaling \$499. The purchase is made with the proceeds of the return using Home Depot store credit card (card# 179104222203) in the amount of \$396.09 and an additional Home Depot store credit card (card#179100731401) in the amount of \$102.91.

Throughout the courses of this investigation, your Affiant has been notified from Home Depot Corporate Investigator, Adam Van Duzer, that multiple ID's have been used to make returns of stolen merchandise at Home Depot. As explained throughout, several ID's used were not used by the individual the ID belongs to and was used fraudulently.

Your Affiant utilized a covert surveillance camera and observed a 1998 Jeep Grand Cherokee. Bearing PA registration KPC0352 arrive in front a storage unit located on Tacoma Street, Philadelphia, PA at approximately 1:52 p.m. on January 29, 2019. Myra Reddy was observed exiting the driver side of the Jeep Grand Cherokee and approaching the storage unit. Reddy was observed wearing a black jacket, black leggings, and black Nike sneakers. Reddy is observed opening and entering the storage unit. At approximately 1:54 p.m., Reddy is observed removing a large black plastic trash bag appearing to be holding various items and placing it into the rear passenger side seat of the 1998 Black Jeep Grand Cherokee. Reddy closes the rear passenger door and reenters the storage unit. At approximately 1:55 p.m., Reddy exits the storage unit and approaches the rear passenger door of the Jeep Grand Cherokee while holding what appears to be a white box and placing it in the rear back seat of the Jeep Grand Cherokee. Van Duzer provided your Affiant with a photograph depicting the Black Grand Cherokee parked at Home Depot and a subject wearing a green jacket and a maroon hairpiece exit the Jeep Grand Cherokee. Van Duzer stated the subject completed a refund without a receipt for two faucets and one thermostat and presented a Pennsylvania identification in the name of Diashauna Coleman. The receipt is date and time stamped (01/29/2019 3:29 pm). The subject successfully returned 3 items totaling \$410.22 which was placed on a Home Depot store credit card (card# 179111709215).

Van Duzer reviewed Home Depot store surveillance footage from January 29, 2019 at the Home Depot, Store #4114 located at 5342 West Baltimore Pike, Primos-Secane, PA 19018. Van Duzer observed the subject that was wearing a green jacket and a maroon hairpiece from the Bensalem store from earlier in the day complete

The Home Depot store surveillance photograph shows the subject is wearing a green jacket and a maroon hairpiece. The receipt is date and time stamped (01/29/2019 7:08 pm). The subject successfully returned 4 items totaling \$227.89 which was placed on a Home Depot store credit card (card# 179099888349). Van Duzer observed Reddy exit the Black Jeep Grand Cherokee and, in the same store located at 5342 West Baltimore Pike, Primos-Secane, PA 19018, she was observed completing a refund with a receipt for one Milwaukee tool and presented a Pennsylvania identification in the name of Myra Reddy. Reddy was observed wearing a black jacket and black leggings. Reddy successfully returned 1 item totaling \$344.52 which was placed on a Home Depot store credit card (card# 179099888094). The receipt is date and time stamped (01/29/2019 7:11 pm).

Van Duzer reviewed Home Depot store surveillance footage from January 29, 2019 at the Home Depot, Store #4181 located at 700 Reed Road, Broomall, PA 19008. Van Duzer observed the subject that was wearing a green jacket and a maroon hairpiece from the Bensalem and Upper Darby stores from earlier in the day complete a refund without a receipt for two faucets and one thermostat and presented a Pennsylvania identification in the name of Tamaria Williford. The Home Depot store surveillance photograph shows the subject is wearing a green jacket and a maroon hairpiece. The receipt is date and time stamped (01/29/2019 7:56 pm). The subject successfully returned 3 items totaling \$410.21 which was placed on a Home Depot store credit card (card# 179069137610). In the same store, the subject (wearing a green jacket and a maroon hairpiece) completed a purchase for various tools utilizing the previously issued store credit card (card# 179069137610) for a total of \$397.00 leaving a remaining store credit balance of \$13.21. The receipt is date and time stamped (01/29/2019 8:09 pm). A tax emempt ID #0603542994 was utilized in this transaction. refund in Bensalem and redeemed it to purchase tile in the amount of \$395.34 leaving a store credit card balance of \$14.88. The receipt is date and time stamped (01/29/2019 8:16 pm). In the same store, the subject (wearing a green jacket and a maroon hairpiece) and Myra Reddy utilized the Home Deport store credit card (card# 179111709215) and (card# 179099888349) to purchase two items totaling \$17.85. The receipt is date and time stamped (01/29/2019 8:25 pm).

Your Affiant has utilized a covert surveillance camera that places the 1998 Black Jeep Grand Cherokee parked outside of Myra Reddy's residence located at 2415 North Opal Street, Philadelphia, PA 19132 as recently as February 4, 2019. At approximately 1:27 p.m., Reddy exits her residence holding a white and red box and places it in the trunk of the 1998 Jeep Grand Cherokee. Reddy was observed wearing a dark-colored jacket, black leggings, a hat, and a large dark-colored purse. Reddy enters the driver seat of the Jeep and exits the vicinity at 1:27 p.m.

Your Affiant utilized a covert surveillance camera and observed a 1998 Jeep Grand Cherokee bearing PA registration KPC0352 arrive in front a storage unit located on Tacoma Street, Philadelphia, PA 19144 at approximately 1:42 p.m. on February 4, 2019. Reddy was observed wearing a dark-colored jacket, black leggings, and a hat. Reddy is observed opening and entering the storage unit and removing two large black plastic trash bags appearing to be holding various items and placing them into the rear passenger side seat of the 1998 Black Jeep Grand Cherokee. Reddy removes a white and black box which appears to have a picture on the front and places it inside the rear back seat of the Jeep Grand Cherokee. Reddy closes the storage unit and exits the vicinity at 1:53 p.m.

CONCLUSION

Your affiant has experience in investigating "booster crews". A "booster" is the informal term used to refer an individual who engages in retail theft. It is also used to refer to an individual who engages in or promotes any part





of the retail theft or refund fraud scheme. A booster crew is sometimes headed by an individual. In this organization, the individual in charge is believed to be Myra Reddy. Your Affiant believes the alleged booster crew is taking either the items and/or merchandise cards to a fence. A "fence" is an individual who knowingly buys stolen property for later resale. The resale sometimes occurs in a legitimate market such as a pawn shop, flea market, or auction setting. The fence thus acts as a middleman between thieves and the eventual buyers of stolen goods who may not be aware that the goods are stolen.

Based upon the above facts, Your Affiant submits that there is probable cause to believe that Myra Reddy, from December 2016 to the present, has organized and operated a theft ring that has targeted Home Depot stores throughout southeastern Pennsylvania. Her organization has been responsible for over \$100,000 worth of loss to Home Depot. She and others under her direction have stolen this merchandise by "box stuffing" this merchandise in a large item's box which is paid for. Reddy and/or her crew later return the merchandise that had been "box stuffed" and not paid for and have utilized over 30 individuals identities when doing so. She and others then obtain store credit for the fraudulent returns. Reddy then sells that store credit at a discount to other members of her organization, who then make purchases from Home Depot.
