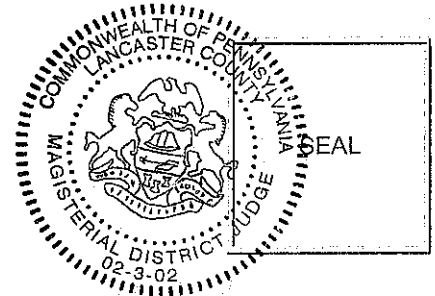

## AFFIDAVIT of PROBABLE CAUSE

Your Affiant is a member of the Pennsylvania State Police currently assigned to the Troop J Criminal Investigation Unit.

On 04/08/19 I was assigned an indecent assault investigation involving a Lancaster County Doctor, William VOLLMAR, The DEFENDANT. William VOLLMAR was a practicing physician at Stephen G. Diamantoni and Associates which has a number of practices in Lancaster County and provided services at area hospitals. VOLLMAR was employed as a physician by Diamantoni and Associates Family Practice from July 1992 through April 2019. VOLLMAR specialized in sports medicine having contracts with the following School Districts: Middletown School District, Lampeter-Strasburg School District, Pequea Valley School District, Lancaster Country Day School, Conestoga Valley School District, Octorara Area School District, Solanco School District, and Thaddeus Stevens College of Technology. VOLLMAR was a medical support member for Pennsylvania Interscholastic Athletic Association (PIAA) for district and state athletic competitions and a member of the PIAA Sports Medicine Advisory Committee.

Dr. William R. VOLLMAR, II, MD, Vollmar Primary Care Sports Medicine, was contracted with Conestoga Valley School District for Medical Consulting Services between July 1, 2018-June 30, 2019.

On 04/29/19 I spoke with the Victim. The Victim began seeing VOLLMAR in the fall of 2017. Between January and February 2019, the Victim, 17YOA at the time of violation, received treatment from the DEFENDANT (55 years old), including a massage in the Conestoga Valley High School Athletic Trainer's Room, 2110 Horseshoe Rd. East Lampeter Township, Lancaster County. This treatment occurred on a Sunday afternoon. During this massage, VOLLMAR reached down the Victim's shorts/underwear and touched the Victim's penis. Between late March and early April 2019, the Victim was treated by VOLLMAR again at the school. At this appointment, VOLLMAR again reached down the front of the Victim's shorts touching his penis. The Victim related he did not give VOLLMAR permission to touch his penis.

Based on the above information, I respectfully request DUE PROCESS.

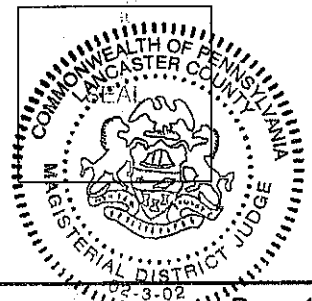



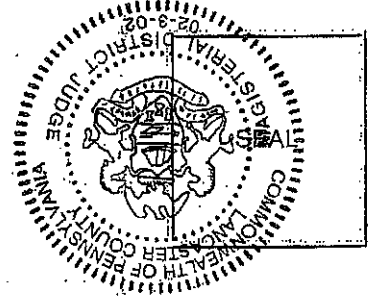

## AFFIDAVIT of PROBABLE CAUSE

Your Affiant is a member of the Pennsylvania State Police currently assigned to the Troop J Criminal Investigation Unit.

On 04/08/19 I was assigned an indecent assault investigation involving a Lancaster County Doctor, William VOLLMAR, The DEFENDANT. William VOLLMAR was a practicing physician at Stephen G. Diamantoni and Associates which has a number of practices in Lancaster County and provided services at area hospitals. VOLLMAR was employed as a physician by Diamantoni and Associates Family Practice from July 1992 through April 2019. VOLLMAR specialized in sports medicine having contracts with the following School Districts: Middletown School District, Lampeter-Strasburg School District, Pequea Valley School District, Lancaster Country Day School, Conestoga Valley School District, Octorara Area School District, Solanco School District, and Thaddeus Stevens College of Technology. VOLLMAR was a medical support member for Pennsylvania Interscholastic Athletic Associate (PIAA) for district and state athletic competitions and a member of the PIAA Sports Medicine Advisory Committee.

On 04/22/19 Tpr. Philip DERN spoke with Victim#1 at PSP-Indiana. Victim#1 began seeing VOLLMAR in the Fall of 2015 for treatment. Victim#1 started receiving massages at the Quarryville Office. VOLLMAR asked Victim#1 to his personal house for treatment, 6 Wyckford Pl. West Lampeter Township, Lancaster County because it would be easier and more convenient beginning in Summer 2016. Victim#1 was treated 3 or 4 times at VOLLMAR's residence. During a home visit massage, VOLLMAR was rubbing Victim#1's inner thigh and had his hands in Victim#1's groin area. VOLLMAR related "Don't mind if I rough the baggage". Victim#1 described VOLLMAR's hands touching his scrotum for 30 to 40 seconds. During another home visit massage, Victim#1 was lying face up on the massage table. VOLLMAR began massaging Victim#1's inner thigh and reached up his boxers touching his penis. Victim#1 related he did not give VOLLMAR permission to touch his penis.

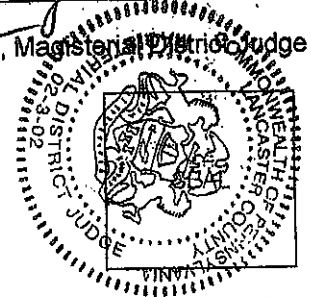



**AFFIDAVIT of PROBABLE CAUSE CONTINUATION**

On 04/16/19 I spoke with Victim#2 at PSP-Lancaster. Victim#2 was a patient of VOLLMAR at VOLLMAR's Quarryville Office. In the summer of 2017, Victim#2 received treatment at VOLLMAR's personal residence, 6 Wyckford Pl. West Lampeter Township, Lancaster County. On one appointment between May and July 2017, Victim#2 received a massage. During this massage, Victim#2 was fully undressed lying on the massage table with a towel covering his genitals. While Victim#2 was lying on his back, VOLLMAR asks if Victim#2 trusted him. VOLLMAR then retrieved lotion, lifted up his towel, and began touching his penis for approximately 1 minute. Victim#2 stopped VOLLMAR from continuing and left the appointment. Victim#2 related he did not give VOLLMAR permission to touch his penis.

On 04/16/19 I spoke with Victim#3. Victim#3 related he became a patient of VOLLMAR's in the early 1990's while attending Conestoga Valley High School. VOLLMAR introduced Victim#3 to sports massage. Prior to Victim#3 turning 18, VOLLMAR would pull his underwear down and rub cream on Victim#3's penis. Between 1996 and 1997, VOLLMAR would "work on Victim#3". This term was described as a sports massage, that ultimately ended in VOLLMAR touching Victim#3's penis with his hands. In 2016, Victim#3 received treatment from VOLLMAR at VOLLMAR's residence, 6 Wyckford Pl. West Lampeter Township, Lancaster County. During a sports massage, VOLLMAR began touching Victim#3's genitals. Victim#3 stopped VOLLMAR and left the appointment. Between June and July 2017, Victim#3 scheduled another appointment with VOLLMAR and was treated at the Quarryville Office, East Drumore Township, Lancaster County. During a massage, Victim#3 removed his clothing and his genitals were covered with a towel. VOLLMAR asked Victim#3 if he was "cool". VOLLMAR removed Victim#3's towel and began performing oral sex on Victim#3. Victim#3 related he did not give VOLLMAR permission to touch his penis.

Based on the above information, I respectfully request DUE PROCESS.
