However, I believe the Zoning Officer added too many criteria that was not intended to be included when interpreting the ordinance. The criteria listed 1 to 4 (Section 160-12.A(69.A)(a), Section 160-12.A(69.A)(c)[2], Section 160-12.A(69.A)(d), and Section 160-12.A(69.A)(e) and (f)) are from the ordinance and it is a standalone ordinance. If you concur with my analysis of the ordinance, I would certainly add a provision stating that this is a standalone ordinance and it is to be interpreted without utilizing other portions of the Code.
