I, Matthew Seefeld, your Affiant, am a Special Agent with the Pennsylvania Office of Attorney General, currently assigned to the Bureau of Criminal Investigations in the Western Regional Office. Your Affiant has more than six (6) years of law enforcement experience. Prior to employment with the Pennsylvania Office of Attorney General, your Affiant was an Officer with the United States Secret Service for three and a half (3 1/2) years.

On Friday, September 13, 2019, the 43rd Statewide Investigative Grand Jury returned the attached presentment recommending that the defendant be charged with the above-referenced criminal offenses. The attached presentment contains specific and articulable facts that make out the probable cause necessary for the above-references criminal offenses.
