AFFIDAVIT of PROBABLE CAUSE

Your affiants are Special Agent Christopher Weaver from the Pennsylvania Office of Attorney General, Bureau of Criminal Investigations and Detective Craig Ripka from the State College Police Department. The Centre County District Attorney referred the case to the Pennsylvania Office of Attorney General. Pursuant to 71 P.S. §732-205(a)(3), the Office of Attorney General assumed jurisdiction of the case. The State College Police continue to assist since they began the investigation.

Your Affiant, Agent Christopher Weaver, is a Special Agent employed by the Pennsylvania Office of Attorney General, Bureau of Criminal Investigation and has been so employed since 2019. Prior to employment with the Pennsylvania Office of Attorney General, he was employed with the State College Police Department for 25 years from 1993 until 2019. He was a Detective for 17 years with the State College Police Department specializing in sexual assault/sex offense investigations. Your affiant has experience investigating homicides, child abuse, assaults, thefts, property crimes, computer crimes, and financial crimes. He holds a Bachelor of Science degree in Criminal Justice from Mansfield University and has also received numerous trainings and certifications in the area of sex offense and sexual assault investigations and criminal investigations. He has also been a trainer who conducted sexual assault trainings for Centre County law enforcement, Sexual Assault Response Team (SART) members, Sexual Assault Nurse Examiners (SANE), Sexual Assault Advocates, and statewide trainings for law enforcement in the area of sexual assault/sex offense investigations.

Your Affiant, Detective Craig Ripka has been employed as a Police Officer with the State College Police Department, State College, PA for a period of 14 years. Prior to that, he was a Police Officer for the Prince William County Police Department in Woodbridge, VA for 2 years. He received his Act 120 certification from the Indiana University Municipal Police Officers Training Academy in 2004. He also attended the Prince William County Police Officers Academy in 2005. He is currently assigned as Detective specializing in sexual assault investigations in the Criminal Investigation Division within the State College Police Department. He has received numerous trainings and certifications in the area of criminal investigations, sexual assault investigations, high tech crimes, crimes against children, and death investigations. He has conducted numerous investigation and has made criminal arrest related to sexual crimes, assaults, thefts, burglaries, computer crimes, and property crimes.

Richard Scott Lenhart is a former Psychologist who had a practice in State College, PA. Lenhart resided in State College, PA with his wife and children.

In 2012, Lenhart's psychology license was suspended. In 2013, Lenhart's psychology license was revoked for violations of the state Board of Psychology. The violations were related to complaints from clients/patients who were being treated by Lenhart in his psychology office. The Department of State and Board of Psychology revoked Lenhart's license for immoral or unprofessional conduct, displaying gross incompetence or misconduct, engaging in sexual intimacies with clients, exploiting the trust and dependency of a client/patient, and engaging in an exploitive dual relationship with patients. The violations occurred in Lenhart's psychology office located in State College, PA from 1994 through 2009.

In 2013, as a result of the information reported to the state Board of Psychology and Department of State a criminal investigation was initiated by the State College Police Department. The investigation was then referred to the Pennsylvania Office of Attorney General for investigation and prosecution.

During the investigation one of the former patients and victims of Lenhart reported that she suspected Lenhart was sexually abusing his daughter. The former patient/victim reported that based upon conversations with Lenhart and

statements he made about his daughter she suspected that he was sexually abusing his daughter. The former patient/victim reported that the conversations with Lenhart regarding his sexual attitudes, his family, and his relationship with his daughter were numerous, lengthy, and in-depth. The former patient/victim reported that these conversations took place with Lenhart over several years while she was being treated as a patient. The former patient/victim reported that Lenhart never made any direct disclosures of sexual abuse, but he talked about his daughter in an inappropriate and sexual way on a regular basis. The patient/victim reported that during this time she was also being sexually assaulted by Lenhart on a regular basis.

In 2014, the police made contact with the victim's mother regarding the reported suspected sexual abuse. The mother reported that she had left her husband and moved out of state with her daughter. The mother reported that her daughter was in counseling and was unable to talk about her relationship with her father. The mother was encouraged to have her daughter continue counseling and to contact the police if her daughter made any disclosures.

In August of 2014, the Pennsylvania Office of Attorney General filed criminal charges against Lenhart for Sexual Assault, Aggravated Indecent Assault, Involuntary Indecent Sexual Assault, Indecent Assault, and Insurance Fraud. The charges were related to Lenhart's sexual contact with patients he was treating over a 15 year period of time.

In 2016, Lenhart pled guilty to Insurance fraud and Indecent Assault and was sentenced to 3 to 6 years in a state correctional institution.

In May of 2018, the victim's mother called and reported that her daughter had made a disclosure of sexual abuse involving her father. The sexual abuse disclosure was made during counseling. The mother reported that her daughter was still unable to talk about the sexual abuse and was continuing with counseling. The mother was advised to continue the counseling with her daughter and to contact the police when her daughter was able to talk about the sexual abuse.

In July of 2019, the victim contacted the State College Police and reported the sexual abuse. The victim indicated that she was ready to file a police report and discuss the sexual abuse that involved her father Richard Scott Lenhart.

In February of 2020, The Centre County District Attorney requested assistance from the Pennsylvania Office of Attorney General's with the investigation. Pursuant to 71 P.S. §732-205(a)(3), the Office of Attorney General assumed jurisdiction of the case. The State College Police continued to assist since they began the investigation.

On March 17, 2020, the victim traveled from out of state to meet with Special Agent Christopher Weaver from the Pennsylvania Office of Attorney General's Office and Detective Craig Ripka from the State College Police Department. The victim agreed to be interviewed and recorded during the interview. Over a two day period of time, the victim made the following report of sexual abuse by her father Richard Scott Lenhart.

The victim was 22 years old and born in 1997, reported that the majority of the sexual abuse occurred in her childhood home located at 293 Homan Avenue, State College, PA. The victim reported that she lived in the home

with her father, mother, and sister for the majority of her childhood. The victim reported that she was adopted by her parents as a young child.

The victim recalls inappropriate and sexual touching and grooming type behavior by her father at a very young age. The victim reported that the touching occurred regularly and eventually turned into sexual intercourse.

Sexual contact occurred over an extended period of time and with frequency. The victim most clearly recalled specific incidents of sexual contact where she suffered pain, where her father inserted his penis into her vagina, or where the incident occurred in connection with an event, holiday, and/or birthday.

The victim described an incident that occurred when she was approximately 8 years old. The victim reported that this was the first time that actual sexual intercourse occurred with her father. The victim reported that other sexual touching and acts had occurred prior to this incident, but this was the first sexual intercourse that she could recall. The victim reported that she knew the exact date of the incident because it occurred on April 16, 2006. The victim reported that she knows the date because it was Easter and her father's birthday on the same day. The victim reported that the incident occurred later at night when she was in bed. The victim reported that at the time she was sharing a room with her sister and her sister would have also been in the room. The victim recalled being woken up by her father and recalled sexual intercourse occurring. The victim reported that this was the first time sexual intercourse occurred. The victim described sexual intercourse as her father putting his penis in her vagina.

The victim reported that she recalled another incident when she was close to her 10th birthday. The victim recalled it being late at night in her bedroom when she was on the first floor of her home. The victim reported that her sister had a bedroom in the basement and her parents' bedroom was across from her room. The victim reported that she recalled her father coming into her room and getting into bed with her. The victim reported that she recalled her father getting on top of her and having sexual intercourse with her. The victim reported that she specifically recalled this incident because it hurt. The victim was able to provide some details and things that she recalled about the incident. The victim recalled her father being on top of her, she recalled being in pain from the sexual intercourse because she was clinching her muscles, she recalled looking at the ceiling fan and seeing the glowing stars on her ceiling. The victim reported that she thinks she was wearing a night gown and her father was in boxers. She reported that she did not remember clothes being off and stated that the clothing was just pulled away to expose body parts. The victim also recalled her father staying in her bed after the intercourse and falling asleep, then leaving her room. The victim reported that she recalled crying afterwards in her bed and trying to be quiet.

The victim reported another incident that occurred when she was approximately 9 to 11 years old. The victim could not recall an exact age or date but stated that the incident occurred in her parent's newly remolded bathroom in their bedroom and that the remodeling had just occurred. The victim reported that this incident happened in the afternoon when she was home alone with her father. The victim stated that she was at home alone with her father. The victim reported that she recalls going into her parents' bedroom with her father and getting into the shower together. The victim reported that this incident was longer and felt like it was "practice" to see what types of things she liked and him trying different things. The victim stated that a lot of different types of touching, positions, and sexual acts occurred. The victim reported that she recalls kissing, sexual touching, and oral sex with her father performing oral sex on her, and her performing oral sex on him, vaginal intercourse, and anal intercourse. The victim reported that they would stop and get out of the shower and take "breaks" and then get back in the shower

and try something different. The victim reported that she was unsure how many times they got in and out of the shower. The victim reported that her father was more gentle with her and nice to her during the incident. The victim reported that she recalled shutting her eyes during the sexual contact and just looking at the tile on the wall. The victim reported that this was the first and only time she could recall any type of anal penetration and remembers feeling her father's penis in her rectum and it hurt. The victim reported that the anal sex did not last long and stated that she remembers it feeling different form the vaginal intercourse and hurting.

The victim reported another incident that occurred when she was 11 or 12 years old. The victim reported that this incident happened at their house and that it was her father's birthday. The victim reported that she remembers passing by her father as he sat on their back porch and he looked like he was angry. The victim reported that her father gave her a look that made her feel like something was going to happen. The victim reported later that night, she was in her bedroom and her father came into her room. The victim reported that at this time she and her sister had their own bedrooms. The victim reported that she switched rooms with her sister and she was now in the bedroom/studio in the basement. The victim reported that she recalls her father coming into her room and having sexual intercourse with her. The victim reported that this was a significant incident because she remembers her father being angry and rough during the sexual intercourse. The victim reported that she had a lot of pain during and after the intercourse and recalls her vagina having redness and being very sore afterwards.

The victim reported another incident that occurred when she was approximately 12 or 13 years old and reportedly before 7th grade. The victim reported that her and her father would play racquetball together at the Intramural Building on the Penn State campus. The victim reported that this was something they did on a regular basis. The victim reported that one night in the winter time when it was snowing out, they had left the house to go play racquetball. The victim reported that they did not go play racquetball and instead her father took her to an unknown place in State College. The victim described the place as a small space with some furniture and no carpet. The victim reported that she recalled seeing the lights of the Bryce Jordan Center while on the way and her father telling her that there was an event going on at the Bryce Jordan Center that night. The victim reported that once they were at the place her father began to have sexual intercourse with her. The victim remembers being in an uncomfortable position during the intercourse. The victim reported that she recalls being up against a wall during the intercourse and feeling really uncomfortable. The victim reported that after the sexual intercourse they went home and never played racquetball.

The victim reported another incident that she knew the exact date for because it was the day her father's psychology license was suspended. The victim reported that she recalls the incident occurring in November of 2012 when she was 15 years old. The victim reported that it was a week day and her mother had picked her up at the high school from cross country practice. The victim reported that her mother told her why her father's psychology license was being suspended. The victim was told that her father was claiming that the allegations made against him were not true. The victim stated that when they go home she saw her father and he was visibly sad and remembers this because he did not typically show emotion. The victim reported that later that night her father had come to her room in the downstairs bedroom/studio and had sexual intercourse with her. The victim described her father as being sad, gentle, and passionate with her during the sexual intercourse. The victim stated that it was a very confusing incident with a lot of emotions and confusion. The victim reported that the incident did last long and she recalls just looking at the ceiling and fixating on the light fixture during the sexual intercourse.

The victim reported that the last incident she recalled occurred after she had moved out of state with her mother in 2013. The victim reported that she had returned to State College around Thanksgiving to visit and stayed with her father during her visit. The victim reported that her father was living with his friend/girlfriend and her young son in the Park Forest area of State College, possibly 690 Galen Drive, State College. The victim reported that she was going to stay with a family friend during her visit. Her father got into a huge fight with the family friend about her staying with her and insisted that she stay with him, since he was her father. The victim reported that she remembers it being a day when they dropped her father's girlfriend off at work. The victim reported that the incident with her father occurred at her father's girlfriends place and that it was in the late afternoon. The victim reported that the incident happened in the bedroom on the bed where her father and his girlfriend slept. The victim reported that she recalled some touching of her hair and her father kissing her neck and then sexual intercourse. The victim reported that she would describe her father as being happy and trying to make the sexual contact about her and not him. The victim reported that after the incident, she returned home and was mentally in bad shape. The victim reported that she also "self-harmed" herself during her visit and did not shower for several days following the incident.

The victim was asked about her self-harming and when it started. The victim reported that she started the "cutting" behavior at around age 10. The victim who had significant visible scarring on her body from the "cutting", reported that she was always unsure why she did it and just recently began to realize that the sexual abuse was the reason. The victim reported that she did not engage in any type of self-harming behavior prior to the sexual abuse by her father.

On 3/10/21, Special Agent Weaver and Detective Craig Ripka attempted to interview Richard Scott Lenhart at the State Correctional Institution at Rockview.

Lenhart was advised of his Miranda rights and stated that he understood, but was unsure if he wanted to speak. Lenhart began to make statements after being advised of his Miranda. Lenhart stated that he never did anything inappropriate with his daughter. Agent Weaver advised Lenhart that based upon interviews with his daughter and witnesses, his daughter was very credible. Lenhart stated that he doesn't think his daughter is lying. Lenhart stated that he believes that she really thinks something happened. Lenhart went on to state again, that he never did anything to his daughter. Lenhart stated that his daughter saw a counselor when she was young and if he had done something to his daughter, she would have said something at the time. Agent Weaver advised Lenhart that most victims of sexual abuse rarely report the abuse at the time and most disclose later in life. Lenhart stated that he feels that his daughter really believes that something happened, but it is fabricated due to other events in her life. Agent Weaver advised Lenhart that he felt he was conveniently using psychology to explain and fit his situation. Lenhart then requested to end the interview.
