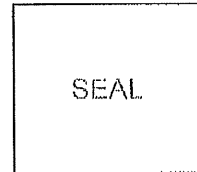



## AFFIDAVIT of PROBABLE CAUSE

1. Your Affiant Agent Thomas Sedor, is a Narcotics Agent employed by the Pennsylvania Office of the Attorney General's Office (PA OAG) . Your Affiant is currently assigned as a Narcotic's Agent in the Region I, Allentown office .
2. Your Affiant has been a law enforcement officer since 1989, with over 25 years being focused on narcotic related investigations.
3. Your Affiant conducted an investigation on Christopher Weikert and his residence – 326 E 8th ST, Apt 11, Northampton, PA 18067. During this investigation, your Affiant established and identified that DEFENDANT Tara Gallucci is Weikert's girlfriend and resides and shares the residence at 326 E. 8th ST, Apt 11, Northampton, PA 18067 with Weikert.
4. During the morning hours of 4/28/21, your Affiant, along with other Agents from the PA OAG and members of the PSP SERT team served a valid search warrant at 326 E. 8th ST, Apt 11, Northampton, PA 18067. The search warrant was signed on 4/27/21 by Northampton County Court of Common Pleas Judge Honorable Abraham Kassis.
5. Shortly after the execution of the search warrant at 326 E. 8th ST, Apt 11, Northampton, PA 18067, Weikert and Galucci were observed driving past the residence in a vehicle previously identified during the course of this investigation. The vehicle fled from Northampton Police, and Weikert escaped the area on foot. Galucci was subsequently taken into custody near the residence.

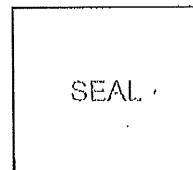

## AFFIDAVIT of PROBABLE CAUSE

6. A search of the residence was conducted and the following items were located:
  - A. A substantial amount of suspected Fentanyl, in various separate packages with a field weight of approximately 25 grams, street value of approximately \$5,000.00
  - B. Approximately 20.5 LBS of crystal methamphetamine, in various separate packages, street value of approximately \$968,200.00
  - C. Several pounds of suspected marijuana
  - D. Paraphernalia to include several digital scales, plastic bags, and marijuana growing operation equipment, indicative of packaging and selling methamphetamine, Fentanyl, and marijuana.
  - E. \$6,668 US currency.
  - F. 5 rifles, 3 revolvers/handguns, and 6 functionally assembled ghost guns
  - G. Indicia of occupancy which identified Weikert & Galucci as being residents and occupants of 326 E. 8th ST, Northampton, PA 18067
6. The suspected Fentanyl, suspected methamphetamine and suspected marijuana was field tested by Agents, and positive results for the presence of fentanyl, methamphetamine and marijuana were received.
7. All of the items seized, were secured in the PA OAG Region I evidence storage.
8. Defendant, Christopher Weikert, has a conviction in Lehigh County PA, for Burglary PACC 3502A, which makes him prohibited from possessing a firearm.
9. These charges were approved by Northampton County CDDA Michael Thompson.
