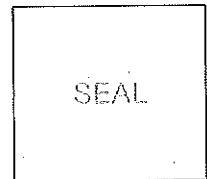

AFFIDAVIT of PROBABLE CAUSE

On June 24th, 2021, your Affiant who is a sworn Narcotics Agent, along with Agents of the Office of Attorney General, executed a lawful search warrant at the residence of 3720 Mountain View Drive, Danielsville, Northampton County, Pennsylvania.

At approximately 6:05 AM the warrant was served and following items were seized:

1. Approximately 1.9 grams of crystal methamphetamine
2. Approximately 294 grams of marijuana
3. Assorted drug paraphernalia including multiple digital scales and empty drug packaging
4. Multiple plastic containers with crystal methamphetamine residue
5. Three (3) firearms, one being a ParaOrdnance .45 caliber pistol, serial P112118
6. \$1,140 US Currency, including prerecorded buy money
7. Three (3) Ghost gun frames (uncompleted)
8. Two (2) 3-D Printers used for printing firearms components

A field test conducted on a random sample of the 1.9 grams of crystal methamphetamine provided a positive reaction, indicating the presence of crystal methamphetamine.


A criminal history check of WILSON revealed that he has previous felony convictions which preclude the defendant from possessing a firearm pursuant to Section 6105 of Title 18, Pennsylvania Crimes Code This convictions are as follows:

- 12/20/2002- Guilty Plea- Aggravated Assault- F2, Common Pleas# 0003195-2001 and plead guilty/assault County prison, 11 Mos 15 Days - 23 Mos
- 12/12/2013- Guilty Plea- Drug Delivery Felony CP-48-CR-0003463-2013 and Plead guilty/ Manufacturer costs/etc. of County prison/ Controlled 001 Yrs 11 Mos.

The Defendant Kenneth WILSON is charged with Possession with Intent to Deliver a Controlled Substance, Possession of a Controlled Substance, Persons not to Possess Firearms, and Dealing in Unlawful Proceeds.

I, MATTHEW PAVLIK, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.
