## Gentlemen,

Perhaps you can assist me in finding the right address to send a NOTICE AS TO CONSTITUTIONALITY of a Muhlenberg Twp Ordinance regulating street use?

I had to make an emergency visit in April to a winter residence I owned since 2009 in Memphis TN due to storm damage to roof and death of caretaker ..and I eventually sold property as it was in bad neighborhood...I purchased a better house in rural Mississippi but while moving items in may I fell and suffered a concussion which I'm slowly recovering from; for weeks my vision was blurry but has IMPROOVED with eye exercises etc .but I was not able to return to my Pa residence .

Recently I discovered twp police were putting tickets on my vehicles parked in front of my suburban residence...alledging I was using street to store vehicles.. in violation of twp ordinance not state motor vehicle code? I informed police in April where I was and not in PA....they did not send me any tickets or citations...I just found out about this and hearing is next week ...I'm not able to appear..I had a train trip cancelled by Amtrak due to flooding in Sept 5th...

I have lived in that house over 30 yrs full-time or part time as it was my parents house and my mother died two years ago so I inherited it last year...and I have had same vehicles parked on street over 20 years and never ticketed in my absence though ticketed for not moving them every seven days per same two ordinance...these vehicles are not a nuisance or causing anyone a serious injury...it's a suburb with plenty of vacant street parking...

It is possible to challenge CONSTITUTIONALITY of a twp ordinance and the state test is ARBITRARY CAPRICIOUS OR CONFISCATORY AS TO PROPERTY OF DEFENDENT...do they expect me to get rid of my personal vehicles or junk them or what? I'm not using street for storage...these vehicles are insured registered licensed operable...I'm just away and suffered an injury which prevented my return...THIS IS NOT FAIR TO BE HARASSING A RESIDENT ABOUT STUFF LIKE THIS ...

This is newer ordinance and did not exist 15 years ago....technically you can be arrested for having a flat tire on a street parked car ...or cracked windshield...or dent in bumper....this is ridiculous a twp has taken this kind of authority over private vehicles ...and these are right in front of my house...I was antiques dealer and used a truck STEPVAN....it has been parked on street since 1999 when I purchased it....and I still use it though I'm semi retired? I have some vintage antique plate vehicles too...

I know the law allows after cited to challenge CONSTITUTIONALITY of twp ordinance but where to send papers...your office reviews farmer related cases...what is address for other civil matters? I never got the tickets or citations either from police dept of local DJ office just a recent notice of hearing and alledged violation? Using street as storage...just because I am away on a trip and suffered a concussion and could not travel or return....this is ridiculous...I think they expect me to get rid of all these vehicles and I've had them for

years and I use them when I at that residence! Once before they cited me for not moving one every seven days per same ordinance? Double Jeopardy might apply?

I paid the 4700\$ property tax on that residence last year .....to Muhlenberg Twp...

What is correct address to send this notice so AG office can review it? It's probably not ACRE office...please reply...thankyou.
