#### AFFIDAVIT of PROBABLE CAUSE

Your Affiant is a member of the Pennsylvania State Police, currently assigned to Troop - D Kittanning, Criminal Investigations Unit. On 02/24/21, I was assigned a Sexual Assault Investigation that was overturned by the Ford City Police Department due to the 54-year-old Female Victim stating the actions occurring in two different counties (Armstrong and Butler Counties).

The Defendant In this case is a Podiatrist Doctor and Associate Director of the Foot and Ankle Wellness Center of Western PA. He has offices in Ford City, Butler, Monaca, Grove City, and Moon Township Pennsylvania.

Upon meeting with the 54-year-old Victim at PSP Kittanning Barracks on 03/10/21 at 1600 hours, she first gave a written statement and was then interviewed regarding the allegations. At that time, she explained she has been treated by the Defendant since approximately 2003, following a car crash where her leg and foot was severely injured. Due to the extent of the Victim's injuries, several surgeries were performed on her leg/foot and she was confined to a wheelchair and leg cast for an extended period of time. She related after the Defendant performed surgeries on her leg/foot she continued to regularly have monthly exams with him for the years to follow until April of 2020. During those routine exams, she would occasionally receive injections into her foot and would receive her monthly prescriptions of pain medication. At the time, the Defendant was her only treating physician, versus receiving treatment at a pain management facility. The Victim stated she use to see the Defendant at his Ford City Office but changed to his Butler Office. During those years of being treated by the Defendant, she related that he had moments of acting inappropriately. It was related the Defendant started by just being over friendly that turned to fiirtatious behavior.

Starting in 2017, the Defendant became more inappropriate by intentionally grazing against her breasts. Those moments of grazing against the Victims breasts increased to hugging the Victim and pressing himself tightly against her. The Victim continued to see the Defendant for treatment as he was her only physician at

the time, it turned to using his hands to feel the Victim's breasts. She related the last time was in April of 2020 where the Victim was seated in an exam chair and leaned forward to tie her shoes. Upon leaning forward, her loose-fitting shirt and bra came away from her body. At that time, the Defendant was standing behind her. When her shirt came forward, the Defendant reached his hands under her shirt and felt her breasts. The Victim related that she never said anything but quickly tucked her arms to her side in shock. It was related the inappropriately touching was frequent and practically every office visit. She stated she felt very uncomfortable with it and it shouldn't have happened. She stated she has never told anyone because of feeling embarrassed over it because she had to go back to get her shots and prescriptions filled.

lasked the Victim why she continued to see the Defendant and dealing with his inappropriate behavior. The Victim related that she held the Defendant as a doctor on a pedestal due to him saving her leg/foot. She related due to not seeing any other physician, the Defendant was also treating her for her pain management. She related she felt trapped and her pain medication was being held over her head.

By the facts aforementioned in this Affidavit of Probable Cause, I respectfully request that a warrant be Issued for the arrest of Dr. Matthew James SABO, so that he may be brought before the court and answer to the charges set forth.
