

Your Building Permit Application has been Denied

After review of the zoning portion of your building permit application for the proposed "agriculture barn for livestock." The denial is based on the following factors.

The proposed 20'x40' barn located at permitted to be placed in the proposed location. According to the attached site plan, your proposed location has placed the barn location 20 feet from the edge of the road. As you are aware your property has two different zoning classifications. One side of the road is A-1 and the other is B-1. As per your application the barn is to be located in the B-1 portion of your property. According to Somerset Township Use chart the setback requirements in B-1 are, Front Yard: 50 feet, Side Yard: 20 feet, and Rear Yard: 50 feet. Therefore, your proposed location of 20 feet from the road does not meet the setback requirements.

To be clear, the denial of your building permit is based on not meeting zoning setback requirements. The barn/structure itself would clearly fall under the agricultural exemption of the Pennsylvania Uniform Construction Code. Therefore, you would only need to do two things to remedy this situation. First, given that you have enough property to meet the 50-foot setback you can relocate barn on the property to where it meets the required setbacks. Second, you would only need to fill out and sign an Agricultural Exemption form supplied by the Township.

As of the date of this letter, it is my determination that your proposed building permit application is denied under the current configuration of the Somerset Township Zoning Ordinance.

An appeal from this determination may be filed with the Zoning Hearing Board. Such an appeal must be filed within 30 days from the date of this letter. If you wish to file said appeal, please contact myself or the Somerset Township planning department for the proper application.
