Justification:

The Extended 24/7 Service, Support and Training will provide OAG: live technical support, unlimited onsite service calls, onsite comprehensive and operational training, valid transfers of OEM factory warranties for new equipment, coverage for all parts and labor to repair defective components under factory warranty.

The Cessna is a mission critical part of the OAG's daily operations. The Extended 24/7 Service, Support and Training plan will greatly benefit OAG by alleviating any unnecessary downtime of the Cessna for repairs and maintenance. It will give OAG a streamlined point of contact, reducing inefficiency, minimizing costs, and preventing service delays that would inevitably develop with vendors who are unfamiliar with the mission suite's proprietary configurations.
